AMENDMENT OF REGULATION 2 OF THE REGULATIONS

1. Regulation 2 is hereby amended by the substitution for Regulation 2 of the following Regulation:

“2 (1). The Council will be responsible for the issuing of the following certificates:

- (a) Senior Certificate;
- (b) National Senior Certificate;
- (c) National Certificate N3;
- (d) General Education and Training Certificate;
- (e) Further Education and Training Certificate;
- (f) Subject certificate;
- (g) Learning area certificate;
- (h) Unit certificate;
- (i) National Senior Certificate;
- (j) Replacement National Senior Certificate;
- (k) Subject statement; or
- (l) Replacement subject statement.

- (2) The National Senior Certificate contemplated in *sub-regulations 1(i) and (j)* may reflect the inscriptions:

- (i) National Senior Certificate (Based on the National Curriculum Statement Grades 10-12); or
- (ii) National Senior Certificate (Arbitur).

AMENDMENT OF REGULATION 15 OF THE REGULATIONS

3. Regulation 15 is hereby amended by the substitution for *sub-regulation 5(a)* of Regulation 15 of the following, paragraph:

“(a) The format of certificates referred to in Regulation 2 will be as contemplated in Appendices B to K appended hereto”.

AMENDMENT OF APPENDICES OF THE REGULATIONS

4. Appendices to the Regulations are hereby amended by the insertion after Appendix I of the Appendix J and K below.

SHORT TITLE AND COMMENCEMENT

5. These Regulations may be cited as the Amendment Regulations for the Issuing of Certificates by the Council, 2009.

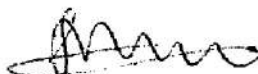

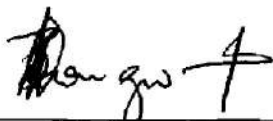
