Levy and interest payable on Piped-Gas Industry

The Minister of Energy with the concurrence of the Minister of Finance has approved the budget and levies for the piped-gas industry in terms of section 2(4) of the Gas Regulator Levies Act No.75 of 2002 as proposed by the National Energy Regulator for the 2010/11 financial year.

The levy for the piped-gas is **19.2807c/Gj** in respect of the amount of gas, measured in Gigajoules, delivered by importers and producers to the inlet flanges of the transmission or distribution pipelines and will be paid by the person holding the title to the gas at the inlet flange.

The interest calculation for the piped-gas is determined in terms of section 4(2) of the Gas Regulator Levies Act No.75 of 2002.

The levy was determined based on an estimated volume of R161.6 million Gj per annum and the 2010/11 Business Plan and Budget requirement, for the regulation of the piped-gas industry, of R31 800 312 submitted to the Minister of Energy.

The National Energy Regulator, acting under section 2(7) of the Gas Regulator Levies Act No.75 of 2002, hereby publishes the 30 days notice in the imposition of the levies for the piped-gas industry at **19.2807c/Gj** for the 2010/11 financial year, as approved by the Minister of Energy with the concurrence of the Minister of Finance.

The collection of the levy will be effective from 1 April 2010.

LEVIES ACT 2004 (No.28 of 2004)****Levy and interest on Petroleum Pipelines Industry**

The Minister of Energy with the concurrence of the Minister of Finance has approved the budget and levies for the petroleum pipeline industry in terms of section 2(4) of the Petroleum Pipelines Levies Act No. 28 of 2004 as proposed by the National Energy Regulator for the 2010/11 financial year.

The levy for the petroleum pipelines is **0.2234 c/litre** in respect of the amount of petroleum, measured in litres, delivered by importers, refiners and producers to the inlet flanges of petroleum pipelines and will be paid by the person holding the title to the petroleum immediately after it has entered the inlet flange.

The interest calculation for the petroleum pipelines is determined in terms of section 4(2) of the Petroleum Pipelines Levies Act No.28 Of 2004.

The levy was determined based on an estimated 18.5 billion litres per annum and the 2010/11 Business Plan and Budget requirement, for the regulation of the petroleum pipelines industry, of R41 236 933 submitted to the Minister of Energy.

The National Energy Regulator, acting under section 2(7) of the Petroleum Pipelines Levies Act No.28 of 2004, hereby publishes the 30 days notice in the imposition of the levies for the petroleum pipelines industry at **0.2234 c/litre** for the 2010/11 financial year, as approved by the Minister of Energy with the concurrence of the Minister of Finance.

The collection of the levy will be effective from 1 April 2010.

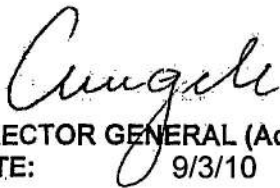

- The taking of raw water for domestic and industrial purposes from natural resources in the areas of jurisdiction of the following municipalities be reduced by 40%, to supply 60% of the unrestricted use. The reduction is based on water consumption in the periods as indicated, and will be adjusted to allow for population growth: Mossel Bay (2008), George (2008), Knysna (2004) and Bitou (2006).
- The taking of groundwater from private boreholes for the irrigation of gardens is not permitted between 7h00 and 19h00 hours.

This Notice overrides any other previous authorisation on water restrictions issued by the Department of Water Affairs relating to this area.
