I, Jeffrey Thamsanqa Radebe, Minister of Justice and Constitutional Development, acting under sections 2(1)(d), 2(1)(g)(ii), 2(1)(*i*A) and 29(1A) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944) as substituted by sections 2 and 7 of the Jurisdiction of Regional Courts Amendment Act, 2008 (Act No. 31 of 2008), hereby with effect from 09 August 2010-

- (a) establish a court for each regional division for the purposes of adjudicating civil disputes contemplated in section 29(1) and 29(1B) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944) as amended by the Jurisdiction of Regional Courts Amendment act, 2008 (Act No. 31 of 2008) (the Act);
- (b) appoint, within each regional division mentioned in Column A of Schedule 1, places listed under Column C of the said Schedule for the holding of a court for the adjudication of civil disputes contemplated in section 29(1) or section 29(1B) or sections 29(1) and (1B) of the Act;
- (c) prescribe, in Column D of Schedule 1, the local limits within which the court sitting at the place in column C shall have jurisdiction; and

(d) determine amounts mentioned in Column B of Schedule 2 for causes of action contemplated in section 29 (1) (a), (b), (d), (e), (f) and (g) of the Act, listed under Column A of the said Schedule in respect of courts for the regional divisions.
