The Minister of Justice and Constitutional Development intends introducing the Criminal Procedure Amendment Bill, 2010, in the National Assembly shortly. The explanatory summary of the Bill is hereby published in accordance with Rule 241(c) of the Rules of the National Assembly.

The **Criminal Procedure Amendment Bill, 2010**, aims to bring the provisions relating to the use of force when effecting an arrest in line with a judgment of the Constitutional Court; and to provide for matters connected thereto.
