### **NOTICE 1010 OF 2010**

#### **DEPARTMENT OF CORRECTIONAL SERVICES**

#### **PUBLICATION OF EXPLANATORY SUMMARY OF CORRECTIONAL MATTERS AMENDMENT BILL, 2010**

The Minister of Correctional Services intends introducing the Correctional Matters Amendment Bill, 2010, in the National Assembly shortly. The explanatory summary of the Bill is hereby published in accordance with Rule 241(1)(c) of the Rules of the National Assembly.

The Correctional Matters Amendment Bill, 2010, aims to amend the Correctional Services Act, 1998, so as to repeal provisions establishing an incarceration framework introduced by the Correctional Services Amendment Act, 2008; to insert new definitions; to provide for a new medical parole system; to clarify certain provisions relating to parole, to provide for the management and detention of remand detainees and to provide for matters connected therewith.

Die Korrektiewe Dienste Aangeleenthede Wysigings Wetsontwerp, 2010, beoog om die Korrektiewe Dienste Wet, 1998, te wysig, deur die herroeping van die bepalings wat die opluitingsraamwerk daarstel, ingevoeg in terme van die Wysigingswet op Korrektiewe Dienste, 2008; om nuwe woordomskrywings in te voeg; om voorsiening te maak vir 'n nuwe mediese parool stelsel; om sekere bepalings met betrekking tot parool op te klaar ; om voorsiening te maak vir die bestuur van en die aanhouding van verhoorafwagtende selgenote en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.
