# EXEMPTION OF TEBOGO ALEX MOGODI t/a MOGODI BURIAL SOCIETY FROM AUDIT REQUIREMENTS

# EXEMPTION OF TEBOGO ALEX MOGODI t/a MOGODI BURIAL SOCIETY FROM AUDIT REQUIREMENTS

## **Extent and conditions of Exemption**

- Tebogo Alex Mogodi t/a Mogodi Burial Society, FSP No. 10851, is hereby exempted from section 19(3) of the FAIS Act with regard to the submission of the 2006 to 2009 audit reports, subject to the conditions that he must—
  - submit an audit report required under section 19(3) in respect of the 2010 financial year end to the Registrar by no later than 30 January 2011; and
  - (b) thereafter submit annually an audit report as required under section 19(3).

# Amendment and withdrawal of Exemption

- 2. The Exemption is subject to-
  - (a) amendment thereof by the Registrar by notice in the *Gazette*; and
  - (b) withdrawal in like manner.

## Short title

 This Exemption is called the Exemption of Tebogo Alex Mogodi t/a Mogodi Burial Society from Audit Requirements, 2010.
