In accordance with the provisions in Article 11.3 of the World Trade Agreement on Implementation of Article VI of the General Agreement on Tariffs and Trade, definitive anti-dumping duty shall be terminated on a date not later than five years from the date of imposition, unless the authorities determine, in a review initiated before that date on their own initiative or upon a duly substantiated request made by or on behalf of the domestic industry, that the expiry of the duty would likely lead to the continuation or recurrence of dumping and injury.

On 26 June 2009, the International Trade Administration Commission (ITAC) notified interested parties through Notice No. 902 of 2009 in *Government Gazette* No. 32333, that unless a substantiated request is made indicating that the expiry of the anti-dumping duty on paper insulated lead covered electric cables originating in or imported from India would likely lead to the continuation or recurrence of dumping and material injury, the anti-dumping duty on the subject products will expire on 10 November 2010.

Napier se grense is aan die suidekant hoofsaaklik omskryf op kwartêre opvanggebiede maar is afgerond tot op die naaste plaasgrense. Die noordelike grens is gebaseer op die skeiding tussen uiteenlopende grondpatrone van skalie en sandsteen en volg die Caledon/Bredasdorp hoofpad op plaasgrense.
