APPLICATION FOR AMENDMENT OF COMMERCIAL SOUND BROADCASTING SERVICE LICENCE BY UMOYA COMMUNICATIONS (PTY) LTD

- The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of section 10(2) of the Electronic Communications Act No. 36 of 2005 ("the Act"), that it has received an application from Umoya Communications (Pty) Ltd, broadcasting as Algoa FM, for the amendment of its licence conditions in terms of section 10(1) of the Act.

Algoa FM must, at the time of submitting its written response, furnish proof to the Authority's satisfaction that it has delivered a copy of the response by hand, or has sent a copy of the response by registered mail or by facsimile, to the relevant persons having made written representations.
