REQUEST FOR THE ESTABLISHMENT OF STATUTORY MEASURES IN THE SOUTH AFRICAN PECAN NUT INDUSTRY:

INVITATION TO DIRECTLY AFFECTED GROUPS TO FORWARD ANY COMMENTS REGARDING THE PROPOSED MEASURES

It is hereby made known, in terms of section 11 of the Marketing of Agricultural Products Act, 1996 (Act No. 47 of 1996), that the Minister of Agriculture, Forestry and Fisheries has received a request from the South African Pecan Producers' Association (SAPPA), on behalf of the directly affected groups in the pecan nut industry, for the establishment of the following statutory measures for a four year period:

- A levy of R0.15 per kilogram (excluding VAT) on all pecan nuts bought or received by a packer or imported by a packer or processor, or produced by a producer, to be payable by a producer or processor or importer;
- The registration of all producers, growers, processors, packers, importers and exporters of fresh pecan nuts and/or pecan nut products, with SAPPA; and
- The keeping of records and submission of returns by all producers, importers and processors of pecan nuts and/or pecan nut products, as may be required by SAPPA, relating to:
 - Pecan nut trees;
 - Volumes of pecan nuts produced; and
 - Volumes imported.

The Department of Agriculture, Forestry and Fisheries or its assignee shall render a copy of all import certificates or furnish the information required by SAPPA contained in such certificates. No records or returns will be required in terms of this measure which could be regarded as confidential or of a marketing nature. Specifically no information which reflects, amongst others, contracting parties, buyers of pecan nut products, cost of services, price of products or similar information will be required.

The proposed levy is needed by SAPPA to fund research projects, technical information and technology transfer; quality control and certification; information and statistics; communication, consumer education and market development; and transformation and training for the pecan nut industry. The proposed levy (R0.15 per kilogram), would represent approximately 0.5% of the domestic producers' selling price (first point of sale). This could create an income of R750 000 per annum based on a conservative pecan nut production estimate of 5 000 tons.

Registration, records and returns are necessary to:

- Ensure the availability and provision of continuous, timeous and accurate information relating to pecan nuts and pecan nut products to all stakeholders in the industry, which is essential in ensuring informed decision making and a stable and profitable industry;
- Ensure adherence to sound product handling, quality control systems and ethical trading; as well as transformation of the industry, and
- Administer the proposed levy.

The establishment of these measures will assist in promoting the efficiency of the marketing of pecan nuts products. The viability of the pecan nuts industry should thus be enhanced. The measures will not be detrimental to the number of employment opportunities or fair labour practice. Any information obtained will be dealt with in a confidential manner and no sensitive client-specific information will be made available to any party without the prior approval of the party whose rights may be affected.

- providing for the hearing of an application for and issuance of a compulsory license,
- amending the structure of the legislation by consolidating related sections into relevant chapters, and
- strengthening the administrative system to achieve the principles of fairness and transparency.

COMPETITION COMMISSION**NOTICE IN TERMS OF SECTION 10(7) OF THE COMPETITION ACT 89 OF 1998 (AS AMENDED): SAPIA GRANTED CONDITIONAL EXEMPTION**

On 19 April 2010, the South African Petroleum Industry Association and its members (herein referred to as "SAPIA") applied to the Competition Commission ("the Commission"), in terms of Section 10(1)(b) of the Competition Act, No.89 of 1998, as amended ("the Act"), to be exempted from the provisions of Section 4 of the Act. The exemption was sought for the period following the end of the short-term exemption which was granted to SAPIA by the Commission for purposes of the 2010 Soccer World Cup, being 31 August 2010 and continuing until 31 December 2015.

Notice is hereby given in terms of Section 10(7) of the Act that the Commission has, in response to the aforesaid application, granted SAPIA conditional exemption, commencing on 03 October 2011 and ending on 31 December 2015. The exemption covers a wide range of agreements and/or practices which, according to SAPIA, are required to ensure the continuity and stability of liquid fuels supply to various sectors and geographic locations of the South African economy.

The agreements and/or practices which have been exempted contravene Sections 4(1)(a) and 4(1)(b)(i) of the Act. However the Commission is satisfied that these agreements and/or practices will contribute towards maintaining the economic stability of the petroleum and refinery industry by reducing the risks of fuels supply interruption, thus meeting the objective set out in Section 10(3)(b)(iv) of the Act.

It should be noted that SAPIA or any other person with substantial financial interest affected by this decision may appeal it to the Competition Tribunal in terms of Section 10(8) of the Act.

The exemption was granted subject to the following conditions:

Preamble

The conditions below only apply for the purpose and duration of the exemption application. The exemption application relates to the cooperation agreements and/or practices between SAPIA and its members at the following stages of the liquid fuels supply chain: Inbound logistics; primary distribution; terminal and depot operation and the specific shared services such as the airport fuelling services and the port joint bunkering services. The exemption does not extend to the wholesale, commercial and retail trade of the supply chain.

1. *The exemption is granted on the basis of the facts and the existing agreements and practices described in the application. Should the facts and existing agreements and practices change materially, including any change caused by the proposed addition of a new participant to an exempt agreement or practice or the conclusion of a new agreement, the Commission should be notified of such change. Any new agreement which affects the agreements and practices described in the exemption application, or any amendment or addendum to agreements contained in the application shall not be of force or effect until approved by the Commission.*
2. *SAPIA and its members and any other approved participants in exempt agreements and practices may not share competitively sensitive information, except for the purposes described in the exemption application.*
3. *If:*
 - 3.1 *a party to an agreement or practice at any stage of the liquid fuels supply chain also acts as an operator of the infrastructure or coordinates the joint use of a facility to which that agreement or practice relates; and*
 - 3.2 *it is necessary for that operating party to be provided with disaggregated volume information of other participants, or any other information which may lead to a substantial lessening or prevention of competition;*

then the operating party must not share that information with the other participants, unless sharing the information is necessary to ensure security, stability and continuity of liquid fuels supply, or is necessary for strictly operational purposes.

The employees of any operating party who receive such information shall ensure that the information is held, maintained and used separately, confidentially and on a need to know basis only.
4. *SAPIA and its members may not share information relating to setting of margins, imposition of levies and / or approval of tariffs, unless required to do so by the Department of Energy or NERSA.*
5. *SAPIA and its members and any other approved participants are required to comply in all material respects with all statutes, regulations and policies which have the force of law, and which directly relate to competition in the petroleum refining and marketing industry in South Africa. These industry regulations include but are not limited to: the Petroleum Products Amendment Act (58 of 2005), the Petroleum Pipelines Act (60 of 2003), the National Ports Act (12 of 2005), and Regulations in terms of the Petroleum Pipelines Act and the National Ports Regulations.*
6. *SAPIA must open up its membership to accommodate both existing and potential marketers in the petroleum and refinery market on fair, reasonable and transparent grounds.*
7. *SAPIA will provide the Commission with regular updates regarding the implementation of the Department of Energy's 'Energy Security Master Plan' (ESMP).*

HOUSING DEVELOPMENT AGENCY REGULATIONS

I, **Tokyo Mosima Gabriel Sexwale**, Minister of Human Settlements hereby under section 32(1) of the Housing Development Agency Act, 2008 (Act No. 23 of 2008), and after consultation with the Agency and Parliament, makes the Regulations in the Schedule.

SCHEDULE

Definitions

1. In these regulations, any word or expression to which a meaning has been assigned in the Act has the meaning so assigned, and, unless the context indicates otherwise—

"Act" means the Housing Development Agency Act, 2008 (Act No. 23 of 2008);

"Chairperson" means the Chairperson of the Board referred to in section 9(2)(c) of the Act; and

"chief executive officer" means the chief executive officer of the Housing Development Agency, referred to in section 17 of the Act;".

Meetings of Board

2. (1) The Board must hold at least four (4) meetings a year.

(2) Meetings of the Board must be held at the time and the place determined by the Board.

(3) The Chairperson—

(a) may at any time convene a special meeting of the Board, and

(b) must convene such a meeting as may be requested by one third of the members of the Board, in writing.

(4) The Chairperson may, from time to time, determine that a meeting be held by telephone, closed-circuit television or other means of communication.

Notices of meetings

3. (1) Except as provided in sub-regulation (3), the Chairperson or the chief executive officer must give at least seven days' written notice to all members of Board of any meeting convened at the request of one third of the members of Board.

(2) The notice contemplated in sub-regulation (1) must—

- (a) specify the date and time of the meeting; and
 - (b) state the general nature of the business of the meeting; and either
 - (i) state the place of the meeting; or
 - (ii) specify the means of communication by which the meeting will be held.
- (3) The chief executive officer or Chairperson must give notice of a meeting—

- (a) in writing; and
- (b) not less than seven days in advance except in cases of emergency or where all members of the Board agree to accept a short notice.

(4) The Board must, if requested by a member of the Board, allow that member to participate in the meeting in the manner contemplated in regulation 9.

(5) The proceedings of or resolutions passed at a meeting of the Board are not invalid merely because—

- (a) the chief executive officer omitted to send a notice to a member of the Board; or
- (b) a member did not receive a notice of the meeting.

Quorum

4. (1) No business may be conducted at a meeting of the Board unless a quorum of members of the Board is present.

(2) A quorum for a meeting of the Board is the majority of its members.

(3) If a quorum is not present within 30 minutes of the time determined for a meeting of the Board, the person presiding at the meeting may adjourn the meeting to the same time and place, seven days after the adjournment.

(4) If a quorum is not present at an adjourned meeting within 30 minutes of the time determined for such meeting, the meeting is automatically cancelled.

Adjournment

5. (1) The person presiding at a meeting at which a quorum is present—

- (a) may adjourn the meeting with the member's consent; and
- (b) must adjourn the meeting if the members so directs.

(2) An adjourned meeting must be held at the time and place agreed to by the members before the meeting is adjourned.

(3) Only unfinished business of an initial meeting can be conducted at an adjourned meeting.

Person presiding at meetings

6. (1) Subject to sub- regulation (2)—

- (a) the Chairperson must preside at all meetings of the Board at which the Chairperson is present; and
- (b) in the absence of the Chairperson, the Deputy Chairperson must preside at a meeting of the Board.

(2) If neither the Chairperson nor the Deputy Chairperson is present, the members present must appoint a member of the Board from amongst themselves to preside at the meeting, unless the Minister has appointed a Chairperson in terms of section 9(2)(c) of the Act.

Taking of decisions at meetings

7. (1) A question arising at a meeting of the Board must be determined by the majority of votes of members of the Board present and voting.

(2) If voting on a question is equal, the person presiding at a meeting has a casting vote in addition to his or her deliberative vote.

Minutes

8. (1) The chief executive officer must ensure that complete and accurate minutes of each meeting are kept.

(2) Draft minutes of each meeting must—

- (a) be presented to the next meeting of the Board for amendment, if necessary, and adoption; and
- (b) be recorded and entered in a book kept for that purpose.

(3) The person presiding at the next meeting must sign and date an affirmation to the effect that the minutes of the previous meeting have been adopted by the members of the Board.

(4) The Chairperson must provide the Minister with a summary of the minutes after every meeting of the Board.

Meetings by telephone or video conference or other means of communication

9. (1) The Board may, by resolution, permit members of the Board to participate in a particular meeting by telephone, video conference or other means of communication.

(2) A member of the Board who participates in a meeting as contemplated sub-regulation (1) must be regarded as being present at the meeting.
