MEMORANDUM OF UNDERSTANDING BETWEEN THE SECRETARIAT OF THE UNITED NATIONS FRAMEWORK CONVENTION ON CLIMATE CHANGE AND ITS KYOTO PROTOCOL (THE SECRETARIAT) AND THE DEPARTMENT OF INTERNATIONAL RELATIONS AND COOPERATION OF THE REPUBLIC OF SOUTH AFRICA

ARTICLE 7

PRIVILEGES AND IMMUNITIES

7 The 1946 Convention on the Privileges and Immunities of the United Nations, to which South Africa is a party, shall apply *mutatis mutandis* to the Meetings. Without limiting the generality of the foregoing:

7.1 Parties. The representatives of Parties to the Convention, the Protocol and Observer States shall enjoy the privileges and immunities provided under Article IV of the Convention on the Privileges and Immunities of the United Nations.

7.2 Specialized Agencies. The representatives of the specialized agencies and the International Atomic Energy Agency shall enjoy the privileges and immunities provided by, respectively, Article VI of the 1947 Convention on the Privileges and Immunities of the Specialized Agencies and Article VI of the Agreement on the Privileges and Immunities of the International Atomic Energy Agency of 1 July 1959.

7.3 Other Participants. DNA representatives and resource persons invited by the secretariat to participate in the DNA Forum not otherwise referred to in Sections 5.1 and 5.2 shall enjoy immunity from legal process in respect of words spoken or written and any act performed by them in connection with their participation, in the DNA Forum.

7.4 Officials. Secretariat staff and other United Nations officials shall enjoy the privileges and immunities provided under Articles V and VII of the Convention on the Privileges and Immunities of the United Nations.

7.5 CDM Executive Board Members and Alternate members. CDM Executive Board Members and Alternate members shall be deemed to be experts on mission and shall enjoy the privileges and immunities provided under Article VI of the Convention on the Privileges and Immunities of the United Nations.

7.6 JISC Members and Alternate Members. JISC Members and Alternate Members shall be deemed to be experts on mission and shall enjoy the privileges and immunities provided under Article VI of the Convention on the Privileges and Immunities of the United Nations.

7.7 In General. All persons performing functions in connection with the Meetings, including those invited pursuant to sections 2 and 3.1.3 shall enjoy such privileges, immunities and facilities as are necessary for the independent exercise of their functions in connection with the Meetings.

7.8 Facilitation of Travel. All participants (including secretariat staff) invited by the secretariat to participate in the Meetings shall have the right of entry into and exit from South Africa and no impediment shall be imposed on their transit to and from the Meetings' premises. They shall be granted facilities for speedy travel. Visas and entry permits, where required, shall be granted free of charge as speedily as possible, provided that general conditions regarding entry have been fulfilled.

7.9 **Premises.** The premises provided for the Meetings and access thereto shall be subject to the authority and control of the secretariat, with assistance by the Department, and shall be inviolable for the duration of the Meetings.

7.10 **Customs.** All equipment, materials and supplies needed by the secretariat for the Meetings, including audio, video, photographic and other professional equipment brought by secretariat staff or media representatives, may be temporarily imported and subsequently exported free of all import, export and customs duties and other taxes.

Article 10

Privileges and Immunities

1. The Convention on the Privileges and Immunities of the United Nations, adopted by the General Assembly on 13 February 1946 (hereinafter "the General Convention"), to which South Africa is a Party, shall be applicable, *mutatis mutandis*, in respect to the Conference and pre-sessional meetings. In particular, the representatives of the Parties referred to in Article 2, paragraph 1 (a), above shall enjoy the privileges and immunities provided under Article IV of the General Convention, the officials of the secretariat and other United Nations officials performing functions in connection with the Conference shall enjoy the privileges and immunities provided under Articles V and VII of the General Convention, and any experts on missions for the United Nations in connection with the Conference shall enjoy the privileges and immunities provided under Articles VI and VII of the General Convention.
2. The representatives of observer States referred to in Article 2, paragraph 1 (b), above shall enjoy the privileges and immunities provided under Article IV of the General Convention.
3. The representatives of the specialized agencies of the United Nations and the International Atomic Energy Agency shall enjoy the privileges and immunities provided by the Convention on the Privileges and Immunities of the Specialized Agencies of 21 November 1947 or the Agreement on the Privileges and Immunities of the International Atomic Energy Agency of 1 July 1959, as appropriate.
4. The other observers referred to in Article 2, paragraphs 1 (d) and (e) above shall enjoy immunity from legal process in respect of words spoken or written and any act performed by them in connection with their participation in the Conference.
5. The staff provided by the Government under Article 8 above shall enjoy immunity from legal process in respect of words spoken or written and any act performed by them in their official capacity in connection with the Conference.
6. Without prejudice to the preceding paragraphs of the present Article, all persons performing functions in connection with the Conference, including those referred to in Article 8 above and all those invited to the Conference, shall enjoy such privileges, immunities and facilities as are necessary for the independent exercise of their functions in connection with the Conference.
7. All persons referred to in Article 2 above shall have the right of entry into and exit from South Africa, and no impediment shall be imposed on their transit to and from the Conference.

area. Visas and entry permits, where required, shall be granted free of charge and as speedily as possible. Arrangements shall also be made to ensure that visas for the duration of the Conference are delivered at the airport of arrival to those who were unable to obtain them prior to their arrival. 8. The Conference Premises specified in Article 3 above are premises of the United Nations in the sense of Article II, section 3, of the General Convention and access thereto is subject to the authority and control of the secretariat. 9. The Government shall allow the temporary importation, tax-free and duty-free, of all equipment necessary for the Conference, including written, audio, video, photographic and other technical equipment accompanying, shipped or dispatched by participants, observers and media representatives, and shall, if necessary, promptly issue any necessary import and export permits for this purpose. The Government shall ensure that a system for speedy clearance of these items for the Conference is in place.


