PART B: MINIMUM WAGES

1. Substitute clause 2 and 3 as reflected in the Government Gazette No. 32060 27 March 2009 with the following:

2. MINIMUM WAGES

1. With the effect from 1 April 2012, an employer must pay a forestry worker at least the minimum wage prescribed in terms of table 1.
2. An employer must pay a forestry worker who works 45 ordinary hours of work per week-
 - (a) at least the weekly or monthly wage set out in table 1; or
 - (b) by agreement between the employer and forestry worker, at least an hourly rate set out in Table 1 for every hour or part of an hour that the forestry worker works.
