#### SCHEDULE

### EXEMPTION OF PARTICULAR PERSONS FROM QUALIFICATION REQUIREMENTS, No. 3 of 2012

#### **Definitions**

- In this Schedule, "the Act" means the Financial Advisory and Intermediary Services Act, 2002, any word or expression to which a meaning is assigned in the Act shall have that meaning, and unless the context otherwise indicates-
  - "Determination of Fit and Proper Requirements" means the Determination of Fit and Proper Requirements for Financial Services Providers, 2008.
  - "qualification requirements" means the applicable-
    - (a) qualification requirement referred to in Column Two of Table E of the Determination of Fit and Proper Requirements; or
    - (b) requirement to complete a qualification from the list of recognised qualifications.

#### Extent, duration and conditions of Exemption

2. The applicants for exemption referred to in Column One of Table A are exempted from the Transitional Provisions in paragraph 10 of the Determination of Fit and Proper Requirements insofar it relates to the qualification requirements, subject to the conditions set out in connection therewith in Column Two of that Table:

#### Amendment and withdrawal of Exemption

- 3. This Exemption is subject to-

#### Short title and commencement

 This Exemption is called the Exemption of Particular Persons from Qualification Requirements, No. 3 of 2012, and comes into operation on the date of publication in the Gazette.
