### **NOTICE OF PUBLIC HEARINGS: ISSUES PAPER: A REVIEW OF THE BROADCASTING REGULATORY FRAMEWORK TOWARDS A DIGITALLY CONVERGED ENVIRONMENT**

The Independent Communications Authority of South Africa ("ICASA") hereby, in accordance with section 4(6) of the Electronic Communications Act ("ECA") No.36 of 2005, gives notice to convene oral hearings on the Issues Paper: A Review of the Broadcasting Regulatory Framework towards a digitally converged environment ("Issues Paper").

ICASA published the Issues Paper: A Review of the Broadcasting Regulatory Framework towards a digitally converged environment on 08 December 2011, Government Gazette Number 34826. The Authority invited interested parties, stakeholders, and the public to respond to the issues raised in the Issues Paper. The closing date for the receipt of written representations was 16 March 2012; which was subsequently amended and extended to mid-day (12:00 pm) on the 16<sup>th</sup> April 2012. The Authority received nineteen submissions. Seventeen of these have indicated their wish to make oral presentations.
