## GENERAL NOTICE ALGEMENE KENNISGEWING

### GENERAL NOTICE 401 OF 2012

#### DEPARTMENT OF JUSTICE AND CONSTITUTIONAL DEVELOPMENT

#### PUBLICATION OF EXPLANATORY SUMMARY OF THE LEGAL PRACTICE BILL, 2012

1. Notice is hereby given in terms of Rule 241(1)(b) of the Rules of the National Assembly that the Minister of Justice and Constitutional Development intends to introduce the Legal Practice Bill, 2012, in the National Assembly shortly.

2. The explanatory summary of the Bill is hereby published in accordance with Rule 241(1)(c) of the Rules of the National Assembly.

The Bill intends to provide a legislative framework for the fundamental transformation and restructuring of the legal profession in line with constitutional imperatives; to provide for the establishment, powers and functions of a single South African Legal Practice Council and Regional Councils in order to regulate the affairs of legal practitioners and set norms and standards; to provide for the admission, enrolment and registration of legal practitioners; to regulate the professional conduct of legal practitioners so as to ensure accountable conduct; to provide for the establishment of an Office of a Legal Services Ombud and the appointment, powers and functions of a Legal Services Ombud; to provide for an Attorneys Fidelity Fund and an Attorneys Fidelity Fund Board of Control; to provide for the establishment, powers and functions of a Transitional South African Legal Practice Council; and to provide for matters connected therewith.

#### DEPARTEMENT VAN JUSTISIE EN STAATKUNDIGE ONTWIKKELING

#### PUBLIKASIE VAN VERDUIDELIKENDE OPSOMMING VAN DIE "LEGAL PRACTICE BILL, 2012"

1. Kennis word hiermee ooreenkomsdig Reël 241(1)(b) van die Reëls van die Nasionale Vergadering gegee dat die Minister van Justisie en Staatkundige Ontwikkeling beoog om die "Legal Practice Bill, 2012", eersdaags in die Nasionale Vergadering in te dien.

2. Die verduidelikende opsomming van die Wetsontwerp word hiermee ooreenkomsdig Reël 241(1)(c) van die Reëls van die Nasionale Vergadering gepubliseer.

Die Wetsontwerp het ten doel om 'n wetgewende raamwerk daar te stel vir die fundamentele transformasie en herstukturering van dieregsprofession in ooreenstemming met konstitutionele imperatiewe; om voorsiening te maak vir die instelling, bevoegdhede en funksies van 'n enkele Suid-Afrikaanse Raad vir Regspraktyk en Streeksrade ten einde die aangeleenthede van regspraktisyens te reël en norme en standarde daar te stel; om voorsiening te maak vir die toelating, ter rolle plasing en registrasie van regspraktisyens; om die professionele gedrag van regspraktisyens te reël ten einde toerekenbare gedrag te verseker; om voorsiening te maak vir die instelling van 'n Kantoor van 'n Ombud vir Regspraktyk en die aanstelling, bevoegdhede en funksies van 'n Ombud vir Regspraktyk; om voorsiening te maak vir 'n Getrouheidsfonds vir Prokureurs en 'n Beheerraad vir die Getrouheidsfonds vir Prokureurs; om voorsiening te maak vir die instelling, bevoegdhede en funksies van 'n Oorgangs-Suid-Afrikaanse Raad vir Regspraktyk; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.
