SOUTH AFRICAN CITIZENSHIP ACT, 1995

REGULATIONS ON THE SOUTH AFRICAN CITIZENSHIP ACT, 1995

The Minister of Home Affairs intends, in consultation with the Minister of Finance, under section 23 of the South African Citizenship Act, 1995 (Act No. 88 of 1995), hereinafter referred to as "the Act", to make the regulations in the Schedule.

SCHEDULE

Definition

1. In this Schedule, a word or expression to which a meaning has been assigned in the Act shall bear the meaning so assigned to it, and unless the context otherwise indicates—

"Director-General" means the Director-General of the Department of Home Affairs; and "the Act" means the South African Citizenship Act, 1995 (Act No. 88 of 1995).

Registration of birth that occurred abroad

- **2.**(1) An application for the registration of the birth of a child born outside the Republic shall be submitted to the office of a South African Diplomatic or Consular Mission or to any office of the Department within 30 days after the birth of such child.
- (2) When a birth is registered in terms of section 13 of the Births and Deaths Registration Act, 1992 (Act No. 51 of 1992), the Director-General shall, upon application, issue a certificate of

acknowledgement of South African citizenship in terms of regulation 12(4), and mail or hand it to the parent or guardian of the child concerned.

Children born of parents who have been admitted into Republic for permanent residence

3. The requirement of having lived in the Republic from the date of birth of a born of parents who have been admitted into Republic for permanent residence

to the date of becoming a major, as contemplated in section 2(3)(a) of the Act should not be construed as restricting a child from leaving the Republic temporarily for visiting any other country for a particular purpose.

Certificate of naturalisation

- **4.**(1) An application for a certificate of naturalisation as a South African citizen in terms of section 5 of the Act shall be in the form and contain substantially the information indicated in Annexure 1 (DHA-63), and be accompanied by the following supporting documents:
 - (a) The applicant's permanent residence permit;
 - (b) a police clearance certificate, not older than six months from the date of submission;
 - (c) the applicant's foreign passport;
 - (d) if the marital status has changed, the marriage or death certificate; and
 - (e) the original Identity Document, or birth certificate in the case of a child.
- (2)(a) An applicant who lodges an application for a certificate of naturalisation referred to in section 5(1)(c) of the Act shall, at the time of his or her application, not have spent more than 90 days outside the Republic in each year during the five-year period of residence.
- (b) The 90 days period contemplated in paragraph (a) shall not accumulate if the applicant did not leave the Republic in a particular year during the five year period.
- (3) An application for a certificate of naturalisation as a South African citizen with regard to a minor child in terms of section 5(4) of the Act shall be made by completing Part II of Annexure 1, as part of an application for a family.
- (4) All members of the family of the applicant included in the application for a certificate of naturalisation must also qualify to be granted with a certificate for naturalisation.
- (5) A certificate of naturalisation as a South African citizen in terms of section 5 of the Act shall be in the form and contain substantially the information indicated in Annexure 2 (DHA-64E).

Proof of renunciation of citizenship of country of origin

5. Proof of renunciation of citizenship of country of origin in terms of section 5(1)(h) of the Act shall be in the form of an official letter by the country concerned confirming that the applicant renounced his or her citizenship of that country, and indicating the date when the applicant ceased to be a citizen of such country.

Citizenship by marriage

- **6.**(1) The period of ordinary residence referred to in section 5(5) of the Act shall be two years at the time of the application for naturalisation: Provided that the applicant shall not have spent more than 30 days outside the Republic in each year during the aforesaid two years.
- (2) The 30 days period contemplated in subregulation (1) shall not accumulate if the applicant did not leave the Republic in a particular year during the two year period.

Loss of South African citizenship

8. An application for retention of South African citizenship contemplated in section 6(2) of the Act shall be in the form and contain substantially the information in Annexure 3 (DHA-1664).

Declaration of renunciation of South African citizenship

- 7.(1) A declaration of renunciation of South African citizenship in terms of section 7(1) of the Act shall be in the form and contain substantially the information in Annexure 4 (DHA-246).
- (2) The form referred to in subregulation (1) shall be completed and subsequently forwarded in duplicate to the Director-General.
- (3) On receipt of the form referred to in subregulation (1) the Director-General shall confirm that it has been duly registered, and provide the person who made the declaration with a copy and file the other copy on that person's records.

Declaration of resumption of South African citizenship

- 11.(1) A declaration of intention of resuming South African citizenship in terms of section 13(2) of the Act shall be in the form and contain substantially the information in Annexure 5 (DHA-246).
- (2) The form referred to in subregulation (1) shall be completed and forwarded in duplicate to the Director-General.

(3) On receipt of the form referred to in subregulation (1) the Director-General shall confirm by way of a certificate in the form and containing substantially the information in Annexure 6 that it has been duly registered.

Certificates with regard to South African citizenship

- **12.**(1) A certificate of confirmation of South African citizenship issued in terms of section 13(2) of the Act shall be in the form and contain substantially the information in Annexure 6 (BI-66E).
- (2) A certificate of resumption of South African citizenship granted in terms of section 13(2) shall be in the form and contain substantially the information in Annexure 7 (BI-237).
- (3) A certificate of South African citizenship in terms of section 15 shall be in the form and contain substantially the information in Annexure 6.
- (4) A certificate of acknowledgement of South African citizenship in terms of section 16 shall be in the form and contain substantially the information in Annexure 8 (BI-75).

Application for resumption of South African citizenship

13. An application for resumption of South African citizenship in terms of section 13(3) of the Act shall be in the form and contain substantially the information in Annexure 9 (BI-175).

Recognition of foreign customary marriages

- **14.** An application for the recognition of foreign customary marriages shall be accompanied by—
 - (a) a certified copy of the marriage certificate; and
 - (b) certified copies of the identity documents or passports of the spouses.

Fees

- 15. The following fees are payable in the respective cases:

(e)	Application for the resumption of South African citizenship, in terms of section 13 of
	the ActR300-00; and
(f)	Application for exemption from the loss of South African citizenship in terms of
	section 26(4) of the Act

Application for exemption from the loss of South African citizenship

16.(1) An application referred to in section 26(4) of the Act shall be in the form and contain substantially the information in Annexure 10 (DHA-1666).

Repeal of Regulations and savings

- **17.**(1) The Regulations made in terms of the Act published by Government Notice No. R.1794 of 17 November 1995 are hereby repealed.
- (2) Anything done under a provision of the regulations repealed by subregulation (1) and which could have been under a provision of these regulations, is regarded as having done under the latter provision.

Short title

18. These Regulations shall be called the Regulations on the South Citizenship, 1995.
