## SCHEDULE 1

The powers and functions of the Abalone Farmers Association of South Africa will be to represent its member's interests and includes the following:

- Commenting on and making inputs on aquaculture policies, strategies, legislation and other documents as and when required;
- Assisting the Department of Agriculture, Forestry and Fisheries with identifying research and other developmental needs for the abalone aquaculture sector;
- Raising funding to promote the Abalone Farmers Association of South Africa's objectives;
- Facilitating the establishment and implementation of certification programmes and food safety programmes;
- Representing its members in any other aquaculture related meetings, forums, workshops, symposia, etc;
- Acting as a formal channel of communication with government on issues related to the abalone aquaculture sector;
- Facilitating transformation in the sector through implementation of development programmes for previously disadvantaged abalone farmers;
- Promoting sound and fair labour practices on abalone farms and promoting socio-economic well being of farm workers and related communities;
- Encouraging its members to implement the Code of Conduct for Aquaculture in South Africa, and where applicable oversee the self-regulation of the abalone aquaculture sector;
- Promoting and marketing of abalone aquaculture sector products;
- Providing training for its members;
- Promoting networking and collating information that is relevant to the abalone aquaculture sector and dissemination thereof for the benefit of its members;
- Facilitating access to basic services for its members, e.g. animal health, environmental monitoring, extension, marketing, etc.

**ESTABLISHMENT OF A STATUTORY COUNCIL**

I, Johannes Theodorus Crouse, Registrar of Labour Relations, hereby, in terms of Section 40(1) of the Labour Relations Act, 1995, establish the Statutory Council for the Fast Food, Restaurant, Catering and Allied Trades.

The sector and area in respect of which the Council is established, is the Fast Food, Restaurant, Catering and Allied Industries, as defined hereunder, in the following areas:

- a) The Province of Western Cape
- b) The Province of Eastern Cape
- c) The Province of Northern Cape
- d) The Province of the Free State
- e) The Province of KwaZulu Natal
- f) The Province of North West
- g) The Province of Mpumalanga
- h) The Limpopo Province; and
- i) The Magisterial Districts of Heidelberg, Nigel, Vereeniging, Vanderbijlpark, Oberholzer, Meyerton and Carltonville.

“Fast Food, Restaurant, Catering and Allied Industries” means the industries concerned with the Tearoom, Restaurant, Catering, Coffee Shop, Pub, Tavern, Roadhouse, Café, Snack Bar, Fast Food Outlet, Convenience Store, Industrial or Commercial Caterer, Function Caterer, Contract Caterer, Catering and associated activities, without in any way limiting the ordinary meaning of the expression, include(s) the sector or sectors and or

establishment(s) in which person(s) carry on the business or in which employers and employees are associated, for the purpose(s) of preparing, baking, providing, supplying, serving, selling, processing, producing meals. These shall include the provision of meals in bulk, edibles and beverages on any premises. Included would be all operations incidental to or in support of the employers' enterprise in relation to any of the above-mentioned activities and would further include:

- (a) all franchisor(s) where such franchisor or their employee(s) are associated for the activities prescribed above; and
- (b) the baking of wheaten products which includes pies, snacks, confectionaries and pizzas for sale directly to customers for consumption whether on or off the premises where such products are baked.

Provided further that, for the purposes of this definition, the following business activities are specifically excluded from the ambit thereof:

- 1) Any casino and hotel industry and all activities that is ancillary and incidental to carrying on the primary activities of such industries. For the purpose of this exclusion, such primary activities are to be carried on, managed and operated solely and exclusively by the hotel or casino, as the case may be, at which these activities are undertaken and such activities must form an integral part of the business and operations of the hotel and casino in question.
- 2) Any catering facility of whatever nature which is owned, managed or operated by sports and recreation clubs on its own premises and which, in turn, provides food and beverages to its members and patrons from the premises from which its sports and recreation facilities are undertaken;
- 3) Any convenience store or convenience outlet which forms part of a filling station provided that such convenience store and outlet is not separately registered and operated from the activities of such filling station;

- 4) Any outlet which prepares and sells food and beverages and is operated as part of a supermarket undertaking and which, in turn, is owned, managed and operated by the supermarket undertaking in question and conducted from the premises of such supermarket undertaking”.

All registered trade unions and registered employers’ organisations engaged in the sector and area concerned are invited to attend a meeting on 18 July 2012, at 10h00, at the CCMA House, 20 Anderson Street, Johannesburg.

The Commission for Conciliation, Mediation and Arbitration has appointed Commissioner, Yusuf Nagdee, to chair the meeting and to facilitate the conclusion of an agreement on:

- (i) The registered trade unions and registered employers’ organisations to be parties to the Council;

and

- (ii) A constitution that meets the requirements of Section 30 of the Act, read with the changes required by the context.





Pursuant to the provisions of sections 47 and 8(2)(b) of the Auditing Profession Act, Act 26 of 2005, the Independent Regulatory Board for Auditors ("IRBA") hereby publishes for general information the following new firm basis for inspections performed.

From 1 April 2012, for all firms categorised as high or special risk (categories A and B respectively), inspections will be billed twice a year based on a percentage of the total audit and other assurance work invoiced by the firm, and declared every calendar year by the firm for each RA.

In principle, high and special risk assurance work will therefore be subject to a three year inspection cycle and billed on a biannual basis at a percentage of the total audit fee base declared.

Low risk assurance work (category C) may be inspected on a reactive basis. This means that the IRBA may inspect low risk assurance work if any information comes to the attention of the IRBA where it is deemed appropriate or necessary to perform an inspection. These inspections will be billed on a cost per hour recovery basis at a rate prescribed by the IRBA.

Re-inspections under categories A and B will also be billed separately on a cost per hour recovery basis at a rate prescribed by the IRBA.
