

In terms of Regulation 169(1) of the Companies Regulations, 2011, under the Companies Act of 2008, the Companies and Intellectual Property Commission ("the Commission") hereby gives notice that **all annual returns** contemplated under Section 33(1) and (2) the Companies Act, **must be filed electronically** through the electronic completion and submission of Forms CoR 30.1 and 30.2 or 30.3, as made available on the Commission's website at [www.cipc.co.za](http://www.cipc.co.za).

Kindly follow the instructions on the website which will guide you through the filing process.

Also note that the operational requirements may be different for the various categories of companies.
