#### INVITATION TO NOMINATE MEMBERS OF THE ICT BEE CHARTER COUNCIL

I, Dina Pule, Minister of Communications, hereby invite nominations for membership of the ICT BEE Charter Council.

The ICT BEE Sector Code was gazetted for implementation on 06 June 2012. The ICT BEE Sector Code requires that an ICT BEE Charter Council be established. The main purpose of the ICT BEE Charter Council shall be to oversee or monitor the implementation of the ICT BEE Sector Code by the ICT sector.

The Council shall consist of nine (9) councillors.

The appointment of councilors shall be drawn from a range of relevant stakeholders including, recognized ICT Industry Associations; NEDLAC, and ICASA. The Minister shall appoint a government representative in the Council.
