The applicants shall be entitled to respond in writing to the written representations made by any interested persons, and such written response must be lodged with the Authority within twenty one (21) working days after the closing date of the written representation. The applicant must, at the time of lodging such written response, furnish to the Authority's satisfaction that it has delivered a copy of such response by hand or has sent a copy of such response by registered mail or facsimile to the relevant person having made such written representation.
