### NOTICE 37 OF 2013

#### NATIONAL LAND TRANSPORT ACT, 2009 (ACT NO. 5 OF 2009)

#### PUBLICATION FOR COMMENTS: DRAFT MODEL TENDER AND CONTRACT DOCUMENTS FOR PUBLIC TRANSPORT SERVICES

The Minister of Transport, Dikobe Ben Martins, do hereby publish the following Model Documents for public comment in terms of section 8(2) read with section 8(1)(u) and section 42(6) of the National Land Transport Act, 2009 (Act No. 5 of 2009) ("the Act"). The Model Documents are for the use by contracting authorities in terms of the Act:

1. Model Contract Documents for Negotiated Contracts (Gross-Based)
2. Model Tender and Contract Documents (Gross-Based)
3. Model Contract Documents for Negotiated Contracts (Net-Based)
4. Model Tender and Contract Documents (Net-Based).

The Minister intends at a later stage to publish

- Documents 2 and 4 in terms of section 42(6)(b) of the Act as a requirement for contracting authorities for subsidised service contracts. Contracting authorities will not be permitted to deviate from them unless agreed to in writing by the Minister; and
- Documents 1 and 3 as guidelines for the use of contracting authorities for negotiated contracts contemplated in section 41 of the Act.
