AMENDMENT OF THE EXEMPTION OF ABSA INSURANCE AND FINANCIAL ADVISERS

SCHEDULE

AMENDMENT OF EXEMPTION OF ABSA INSURANCE AND FINANCIAL ADVISERS

Definitions

1. In this Schedule-

“**the Exemption**” means the Exemption of ABSA Insurance and Financial Advisers, 2012, published by Board Notice 114 of 2012 in *Government Gazette* No. 35488 of 2 July 2012.

Amendment of the Exemption

2. Paragraph 2 of the Schedule to the Exemption is hereby amended by the substitution of-

(a) the date “31 December 2012” in paragraph 2(1)(a) of the date “31 December 2013”;
and

(b) the date “31 December 2012” in paragraph 2(2) of the date “31 December 2013”.

Short title

3. This Notice is called the Amendment Notice of the Exemption of ABSA Insurance and Financial Advisers, 2013, and came into operation on 1 January 2013.
