GENERAL NOTICE – SUBMISSION OF ANNUAL FINANCIAL STATEMENTS FOR 2012– 2013 ASSESSMENT PERIOD BY ALL LICENSEES

1. The Independent Authority of South Africa (“the Authority”) hereby gives notice in terms of section 4(3) (b) and (g) of the ICASA Act No.13 of 2000 (“the Act”), as amended.
2. In terms of the Regulations regarding Standard Terms and Conditions for Individual and Class Licences, Government gazette number 33294 and 33296 respectively. The Regulation provides amongst others the following:
 - (1) *“The Authority may in the course of carrying its obligations under the Act require a Licensee to provide information, so as to enable it to:*
 - (a) *“monitor...compliance with License conditions and other requirements of the Act and related legislation”.*
 - (b) *“allow for the assessment and allocation of applicable Fees and related requirements”.*
3. All Licensees are requested to submit within (6) six months of their financial year end:
 - (a) Audited Annual Financial Statements; or
 - (b) Financial Statements signed by accounting officer of the Licensee, for 2012 - 2013 compliance assessment period; and
 - (c) If licensee has not commenced operation, Licensee is requested to submit formal letter stating that they have not commenced operation.

Licensees must submit the required financial statements based on their financial year end.
