STANDARDS ACT, 2008 STANDARDS MATTERS

In terms of the Standards Act, 2008 (Act No. 8 of 2008), the Council of the South African Bureau of Standards has acted in regard to standards in the manner set out in the Schedules to this notice.

All South African standards that were previously published by the South African Bureau of Standards with the prefix "SABS" have been redesignated as South African national standards and are now published by the SABS Standards Division (a division of SABS) with the prefix "SANS".

A list of all existing South African national standards was published by Government Notice No. 1373 of 8 November 2002.

In the list of SANS standards below, the equivalent SABS numbers, where applicable, are given below the new SANS numbers for the sake of convenience. Standards that were published with the "SABS" prefix are listed as such.

SCHEDULE 1: ISSUE OF NEW STANDARDS

The standards mentioned have been issued in terms of section 16(3) of the Act.

SANS 3000-2-4:2013 RSR 2-4	Railway safety management - Part 2-4: Technical requirements for engineering and operational standards - Train authorization and control, and telecommunication. Schedule

Definitions

1. Any word or expression to which a meaning has been assigned in the Act,

has the meaning so assigned and, unless the context indicates otherwise -

"ad-hoc inspections" means inspections performed at location or facility normally conducted to verify the information contained in the initial report, or to verify nuclear material before it is exported or upon import;

"**complementary access**" means access provided to the inspectors under the additional protocol at any location or facility in order to assure the absence of undeclared material and activities;

"containment" means the use of seals to provide assurance of the physical integrity of an area or item in order to prevent undetected access to or movement of nuclear material or safeguards-relevant equipment and data;

"facility" means a reactor, critical facility, conversion plant, fabrication plant, reprocessing plant, an isotope separation plant or a separate storage installation; or any location where nuclear material is customarily used in amounts greater than one effective kilogram;

"IAEA" means International Atomic Energy Agency, a United Nations organisation that serves as the global focal point for nuclear co-operation;

"inspections" means a set of activities carried out by inspectors at any location, facility or any means of conveyance to verify that nuclear material, restricted material and nuclear related equipment and material are used in peaceful nuclear activities or are adequately accounted for;

"inspections activities" means verification activities carried out by inspectors during and in connection with inspections at any location, facility or any means of conveyance;

"location" means any installation which is not a facility, where nuclear material is customarily used in amounts of one effective kilogram or less;

"means of conveyance" means any act of conveying, carrying or transporting nuclear material;

"protocol additional to safeguards agreements (additional protocol)" means agreement between the Government of South Africa and the IAEA specifying, the additional authority necessary for the IAEA to fully implement its obligations under comprehensive safeguards agreement pursuant to the Treaty on the Non-Proliferation of Nuclear Weapons (NPT) entered into force on 13 September 2002;

"routine inspections" means inspections performed at location or facility on defined periods such as monthly, quarterly, annually;

"**safeguards**" means measures used to verify that civil nuclear material are accounted for and are not diverted to undeclared uses or activities and the correctness and the completeness of the declarations made by facilities about their nuclear material and activities;

"safeguards visit" means the presence of inspectors at any location or facility for purposes other than a safeguards inspection or complementary access;

"special fissionable material (or special fissile material)" means plutonium-239; uranium-233; uranium enriched in the isotopes 235; any material containing one or more of the foregoing material and such fissionable material;

"special inspection" means an inspection deemed to be special when it is either additional to the routine inspection effort, or involves access to information or locations in addition to the access for routine and ad hoc inspections, or both;

"**surveillance**" means the use of equipment, usually optical equipment such as video cameras, to confirm information on the movement of nuclear material or detect tampering with containment or safeguards relevant equipment, samples and data;

"the Act" means the Nuclear Energy Act, 1999 (Act 46 of 1999); and

"unannounced inspections" means inspections performed at location or facility for which no advance notice is provided.

Scope

2. These measures set out the scope for implementation and application of the Safeguards Agreement, Additional Protocol and the Act in order to timeously detect and identify nuclear material intended to be used for peaceful nuclear activities and deter the diversion of such nuclear material to the manufacture of nuclear weapons or other nuclear explosive devices or for the use in connection with any other purpose that is unknown.

Types of inspections and activities for monitoring compliance

3. (1) Any person in possession of, handling, acquiring, using, disposing, processing, enriching or reprocessing, manufacturing or storing, nuclear material and equipment must allow inspectors appointed under section 53 and the designated inspectors of the International Atomic Energy Agency to enter

and carry out, without hindrance, inspections at any nuclear installation or site with a view to monitoring compliance with Chapter III of the Act.

(2) The types of inspections to be carried out by inspectors include, but are not limited to:

- (i) Ad-hoc inspections;
- (ii) routine inspections;
- (iii) special inspections;
- (iv) safeguards visits;
- (v) unannounced inspections; and
- (vi) complementary access.

(3) An inspector carrying out complementary access inspections must give at least two hours advance notice and 24 hours notice for advance notice inspections.

- (4) The inspection activities carried out include but are not limited to:
 - (i) records examination;
 - (ii) visual observation and taking of photographs where necessary;
 - (iii) environmental sampling;
 - (iv) utilization of radiation detection and measurement devices;
 - (v) application of seals and other identifying and tamper-indicating devices;
 - (vi) design information verification; and
 - (vii) any inspection activity deemed necessary.

Inspector's access to monitor compliance with Act

- 4. An inspector performing inspection or investigation in terms of section 37(1) (a), (b) and (c) of the Act must before entering any land, premises, place or means of conveyance—
 - (a) introduce himself or herself to the responsible official on the land, premises, place or means of conveyance;
 - (b) furnish official notification including proof of identity and inspection schedule;
 - (c) explain the purpose of inspection or investigation;

- (d) provide a brief summary of how the inspection will be conducted;
- (e) request the responsible official to sign the consent form attached in Annexure A for the release of any information which might be required; and
- (f) request the responsible official to be available during the inspection.

Inspector's powers of search, seizure, etc

- **5.** (1) An inspector acting on the authority of a warrant referred to in section 38(1) (a) and (b) of the Act may—
 - (a) attach any material or equipment; or
 - (b) immediately remove any nuclear material or nuclear related equipment the possession of which he or she believes on reasonable grounds to be unlawful and found on any land, premises, place or means of conveyance.
 - (2) An inspector acting in terms of section 38(3) of the Act may-
 - (a) exercise any of the powers contemplated in section 38 (2) (a) to (f) excluding the powers in terms of section 38 (2) (e) to take a sample of any mineral, material or substance from below the surface or land; however such a sample may be taken from below with the consent of the responsible official by completing and signing the consent form attached in **Annexure A**; or
 - (b) take an inventory of any nuclear material or nuclear related equipment.

Means of gaining entry into any land, premises, place or means of conveyance.

6. (1) A responsible official at the land, premises, place or in charge of means of conveyance must allow an inspector access to the land, premises, place or means of conveyance to monitor compliance.

(2) An inspector acting on the authority of a warrant issued under section 40 of the Act may gain entry into the land, premises, place or means of conveyance.

Furnishing of information as required by the Additional Protocol

- **7.** (1) Any person in possession of, handling, acquiring, using, disposing, processing, enriching or reprocessing, manufacturing or storing, nuclear material, restricted material and nuclear related equipment and material may at any time be required to furnish information on the following:
 - (a) General description of and information specifying the location of nuclear fuel cycle-related research and development activities not

involving nuclear material carried out anywhere that are funded, specifically authorised or controlled by, or carried out on behalf of the Government;

- (b) Operational activities of safeguards relevance at facilities and any locations where nuclear material is customarily used;
- (c) General description of each building on each site, including its use and contents whereby a map of the site must form part of the general description;
- (d) Description of the scale of operations for each location engaged in the activities specified in Annex I of the Additional Protocol;
- (e) Location, operational status and the estimated annual production capacity and actual annual production of uranium and thorium mines and concentration plants;
- (f) Import and export of source material which has not reached the composition and purity suitable for fuel fabrication or being isotopically enriched.
- (g) Quantities, uses and location of nuclear material exempted from safeguards;
- (h) The location or further processing of intermediate or high level waste containing plutonium, high enriched uranium or uranium-233 which safeguards have been terminated;
- (i) International and national transfers of specified equipment and nonnuclear material as described in the Government Notice 207 of 2009 issued by the Department of Energy (Declaration of certain substances, materials and equipment as restricted material, source material, special nuclear material and nuclear related equipment and material as indicated in Government Notice No.740, Schedule 1, 2, 3 and 4 respectively);
- (j) General plans for the succeeding ten-year period relevant to the development of the nuclear fuel cycle including planned research and development activities;
- (k) General description of activities and the identity of the person or entity carrying out such activities, at locations identified by the Agency outside a site which might be functionally related to the activities of that site;

(2) A person responsible for a location or facility must upon request, provide amplifications or clarifications of any information that is provided under additional protocol, in so far as it is relevant for the purpose of safeguards.

Offences and Penalties

8. Any person or a person responsible for a location or facility, who contravenes or fails to comply with these measures, is guilty of an offence and liable on conviction to a fine or term of imprisonment not exceeding 12 months.

GUIDELINES AND CONDITIONS PERTAINING TO AN AGRICULTURAL SAFEGUARD APPLICATION IN TERMS OF ARTICLE 16 OF THE AGREEMENT ON TRADE, DEVELOPMENT AND CO-OPERATION BETWEEN THE EUROPEAN COMMUNITY AND ITS MEMBER STATES AND THE REPUBLIC OF SOUTH AFRICA (THE TDCA)

1. PURPOSE

1.1 The purpose of this document is to provide a reference and procedural guide pertaining to the application for safeguard action in terms of Article 16 of the TDCA.

2. SCOPE

2.1 The scope of this document covers the application process by applicants for safeguard action in terms of Article 16 of the TDCA which provides as follows:

"Notwithstanding other provisions of this Agreement and in particular Article 24, if, given the particular sensitivity of the agricultural markets, imports of products originating in one Party cause or threaten to cause a serious disturbance to the markets in the other Party, the Cooperation Council shall immediately consider the matter to find an appropriate solution. Pending a decision by the Cooperation Council, and where exceptional circumstances require immediate action, the affected Party may take provisional measures necessary to limit or redress the disturbance. In taking such provisional measures, the affected Party shall take into account the interests of both Parties.".

3. PROCEDURE

3.1 In order for the Department of Trade and Industry (**thedti**) to raise the matter of a serious disturbance in the Cooperation Council, it will need to have a case to present to the Cooperation Council, i.e. facts demonstrating that imports from the EU are causing or threatening to cause a serious disturbance to the SA market. Further, if there is the need for immediate action pending a decision by the Council, a case will need to be made why exceptional circumstances exist that warrant such action. Facts supporting these allegations must be set forth in an application to the International Trade Administration Commission of South Africa (ITAC).

- 3.2 Prior to the submission of an application with ITAC, the industry concerned must lodge a request with the Minister of Trade and Industry to invoke the remedies under Article 16 of the TDCA.
- 3.3 Should the Minister of Trade and Industry be in agreement with the request to invoke the said remedies, the Minister will request the Minister of Economic Development to instruct the International Trade Administration Commission of South Africa (the Commission), in terms of Section 16(d)(i) of the International Trade Administration Act, 2002 (Act 71 of 2002) (ITA Act) to investigate and evaluate an application for agricultural safeguard action in terms of Article 16 of the TDCA.
- 3.4 The industry concerned must then submit an application to the Commission, in the prescribed form. The Commission will consider the application and if warranted, initiate an investigation and publish a notice in the *Government Gazette* for comment. A period of 20 days from the date of publication of the initiation notice will be provided for interested parties to submit comments to the Commission.
- 3.5 The rules relating to confidential information as contained in the ITA Act will apply to ALL correspondence, which unless clearly indicated to be confidential and filed together with a non-confidential version, will be placed on the public file and be made available to other interested parties. A public file will be available for inspection at the Commission's offices by all interested parties, by appointment and interested parties are encouraged to inspect the public file regularly.

- 3.6 All interested parties will be informed of the essential facts to be considered by the Commission in making its preliminary determination. All interested parties will receive 7 days to comment on the essential facts. The Commission may grant parties a single extension on good cause shown. The Commission will take all relevant comments on the essential facts into consideration in its determination.
- 3.7 Taking comments into account, the Commission will then make a preliminary determination, which will form the basis for **thedti** to raise the matter in the Cooperation Council.
- 3.8 Should the applicant indicate that exceptional circumstances exist and the Commission so determines, it may, once **thedti** has raised the matter in the Cooperation Council, request the Commissioner for South African Revenue Service (SARS) to impose provisional measures. Such measures will take the form of a provisional safeguard duty.
- 3.9 The provisional measures will stay in place until such time a decision has been reached by the Cooperation Council.

4. APPLICATION

- 4.1 Applications for safeguard action in terms of Article 16 of the TDCA must be addressed to the Chief Commissioner, International Trade Administration Commission of South Africa, Private Bag X 753, Pretoria or delivered by hand to the dti Campus (Block E), 77 Meintjies Street, Sunnyside, Pretoria, 0002.
- 4.2 Applications must be submitted according to the requirements reflected in the attached application form (See Annexure A).
- 4.3 Applicants should provide full and accurate information and wherever possible provide supporting documentary evidence from commercial or governmental

sources, e.g. commercial invoices or offers, official trade and production statistics. Failure to do so could detrimentally affect the case of the applicant. The Commission will not consider unsubstantiated information. All cost related information should be reconcilable to the financial statements or management accounts.

- 4.4 The Trade Remedies unit offers a public liaison service and if any party has particular problems in answering the questionnaire or requires more information or clarification on policy issues the staff of the Trade Remedies section are ready to discuss these issues and to provide assistance. Please feel free to contact Ms Carina van Vuuren (012 394 3594).
- 4.5 If the application is based in part on confidential material the application must contain a non-confidential version of the confidential material together with an explanation of why it is confidential. Section 33 of the ITA Act provides as follows:
 - "(1) A person may, when submitting information to the Commission, identify information that the person claims to be information that –
 - (a) is confidential by its nature; or
 - (b) the person otherwise wishes to be recognized as confidential.
 - (2) A person making a claim in terms of subsection (1) must support that claim with -
 - (a) a written statement in the prescribed form-
 - explaining, in the case of information that is confidential by its nature, how the information satisfies the requirements set out in the definition of "information that is by nature confidential" in section 1(2); or
 - (ii) motivating, in the case of other information, why that information should be recognized as confidential; and
 - (b) either –
 - (i) a written abstract of the information in a non-confidential form; or
 - (ii) a sworn affidavit setting out the reasons why it is impossible to comply with subparagraph (i)."

These summaries should be in sufficient detail to permit a reasonable understanding of the substance of the information submitted in confidence. Therefore where confidential and non-confidential versions are supplied, parties must:

- (1) Indicate where information has been omitted in each case;
- (2) Provide reasons for confidentiality in each instance;
- (3) Provide a summary of the confidential information which permits a reasonable understanding of the substance of the confidential information in each instance; and
- (4) Where information is not susceptible to a non-confidential summary, indicate this in each instance and provide a sworn affidavit setting out the reasons why the information is not susceptible to summarization.

A sworn affidavit is defined as a written sworn statement of fact voluntarily made by an affiant or deponent under an oath or affirmation administered by a person authorized to do so by law. Such statement is witnessed as to the authenticity of the affiant's signature by a taker of oaths, such as a notary public or commissioner of oaths. An affidavit is a type of verified statement or showing, or in other words, it contains verification, meaning it is under oath or penalty of perjury and this serves as evidence to its veracity and is required for court proceedings.

The Commission will not formally accept an application until a proper nonconfidential version has been submitted in accordance with the above guidelines. If, in terms of section 34 of the ITA Act, the Commission finds that a request for confidentiality is not warranted and if the applicant is either unwilling to make the information public or to authorize its disclosure in summarized format, the Commission will not consider such information in determining the merits of the application.

Please take note that the rules relating to confidential information and the submission of non-confidential versions of submissions applies to ALL correspondence, which unless clearly indicated to be confidential and filed together with a non-confidential version, will be placed on the public file and be made available to other interested parties. If a document is indicated to be confidential but a proper non-confidential document complying with the above-mentioned rules is not filed, then the document will not be taken into

consideration by the Commission. The public file is available for inspection at the Commission's offices by all interested parties, by appointment.

- 4.6 Note that interested parties are encouraged to inspect the public file regularly. The Commission and the Trade Remedies section will not check the public file on interested parties' behalf.
- 4.7 Information should be submitted in hard copies as well as in electronic format, such as on compact disks or flash disks. The Commission's computer system is based on Windows and it uses Excel and MS Word software. The disks must not be write protected and labeled clearly indicating:
 - 1. Applicant's name;
 - Product(s) concerned;
 - 3. Type of information on the disk;
 - 4. Software used; and
 - 5. Whether or not confidential.
- 4.8 The Commission may verify information submitted. Should it be found that the information submitted is false or misleading; the Commission may decide not to proceed with the investigation.

5. CONDITIONS

5.1 South African producers representing at least 50% of the total volume produced by all producers that express an opinion on the investigation must support the application, and that a minimum of 25% (by production volume) of the total industry must support the application. Without this support ITAC cannot accept an application for investigation. Letters of support for or opposition to the application must be attached to the application as Annexure 5.1. Additionally, the Commission may not make a preliminary or final determination of serious disturbance unless it has considered evidence relating to "a major proportion" of the SA industry.

- 5.2 A like product is defined as "a product which is identical, i.e. is alike in all respects to the product under consideration, or in the absence of such a product, another product which, although not alike in all respects, has characteristics closely resembling those of the product under consideration.", while a directly competitive product is a product, other than a like product, that competes directly with the product under investigation.
- 5.3 The following factors will be considered by the Commission in making a determination of serious disturbance:
 - a. the rate and volume of the increase in imports of the product concerned from the EU
 - (i) in absolute terms; or
 - (ii) relative to the production and demand in SA; and
 - b. whether the SA industry is experiencing:
 - (i) price suppression;
 - (ii) price depression;
 - (iii) price undercutting/price disadvantage with regard to EU as well as other imports;
 - (iv) a decline in exports;
 - (v) a change in market share;
 - (vi) any other relevant factors placed before the Commission.

None of these factors listed above is necessarily decisive on its own.

The information requested must relate only to the affected SA product that is a like or directly competitive product to the product under investigation.

5.4 The South African industry should provide the information as requested in Annexure A.

Designation by the Governor of the South African Reserve Bank in terms of section 4A (4) of the National Payment System Act, 1998 (Act No. 78 of 1998) as amended:

DESIGNATION OF THE SOUTHERN AFRICAN DEVELOPMENT COMMUNITY INTEGRATED REGIONAL ELECTRONIC SETTLEMENT SYSTEM AS A DESIGNATED SETTLEMENT SYSTEM

1. Introduction

The South African Reserve Bank ("Reserve Bank"), is empowered to designate a settlement system as a designated settlement system in terms of section 4A (4) of the National Payment System Act, 1998 (Act No. 78 of 1998), as amended ("the Act"). Such designation may be made if the designation is in the interest of the integrity, effectiveness, efficiency or security of the payment system.

The objective of this Designation Notice is to designate the Southern African Development Community ("SADC") Integrated Regional Electronic Settlement System ("SIRESS") as a designated settlement system and specify the Reserve Bank as the designated settlement system operator ("SIRESS Operator"). The designation will enable the SIRESS Operator to have a settlement account with the Reserve Bank, i.e., a real-time gross settlement account in the Reserve Bank's South African Multiple Option Settlement ("SAMOS") System.

2. SADC Integrated Regional Electronic Settlement System

2.1 The SADC Protocol on Finance and Investment provides for amongst others, cooperation on payment, clearing and settlement systems among SADC central banks.

- 2.2 In implementing co-operation on payment, clearing and settlement systems among SADC countries, the Reserve Bank, with the collaboration of some SADC countries has developed the SIRESS for the SADC regional clearing and settlement system.
- 2.3 SIRESS is an automated, real time gross, cross border settlement system for the SADC, provided to the SIRESS participants by the SIRESS Operator, including all the technical infrastructure and business components thereof.

3. Designation

The Reserve Bank has considered the provisions of the Act together with all other relevant factors and has deemed it to be in the interest of the integrity, effectiveness and security of the payment system to designate the SIRESS;

THEREFORE, I, Gill Marcus, Governor of the Reserve Bank, hereby, with effect from 22 July 2013

- in terms of section 4A (4) of the Act read with section 4A (5) (a), designate the SIRESS as a designated settlement system for purposes of the Act; and
- (2) in terms of section 4A (5) (b), specify that the Reserve Bank shall be the operator of the SIRESS and shall function as the designated settlement system operator of the SIRESS.

4. Conditions

The Reserve Bank may vary or revoke the designation of the settlement system by notice in the Government Gazette.
