**NOTICE OF AN APPLICATION FOR AN EXEMPTION IN TERMS OF SECTION 10(1)(a)
OF THE COMPETITION ACT 89 OF 1998:**

SOUTH AFRICAN SQUID EXPORTERS OF SOUTH AFRICA

An application for an exemption from the provisions of the Competition Act 89 of 1998, as amended ("the Competition Act") has been filed with the Competition Commission of South Africa ("the Commission") by South African Squid Exporters of South Africa (SASEA) ("SASEA"), in terms of Section 10(1)(a) if the Competition Act¹.

SASEA is a non-profit organization that exists independently of its members as a distinct and legal entity and body corporate established to promote the collective interests of current and future squid exporters in South Africa. SASEA's current members constitute over ninety-five per cent by number of all South African exporters of South African *Loligo Reymaudi* Squid ("Squid").

The application for exemption is in respect of a proposed arrangement by SASEA and its members to obtain and circulate up-to-date and current market information on the demand and supply conditions in the Squid market for a period of ten years. SASEA has alleged that the nature of the catching and processing Squid in conjunction with elevated bargaining power available to foreign buyers, has significantly depressed the price that SASEA members can obtain for their product. According to SASEA, the Squid export market is characterised by asymmetric information between local exporters and foreign buyers in relation to market information such as quantities available to the market. Foreign buyers obtain this information early in the season when up to fifty per cent of the annual catch is made and leverage off their information advantage to negotiate the export price with SASEA members. This export price will form a base off which adjustments take place during the course of the year.

Furthermore, SASEA alleges that about fifty per cent of the ownership stake in Squid firms is in the hands of historically disadvantaged individuals ("HDIs"), more than ninety per cent of the workforce is HDI and more than fifty per cent of directorships are HDI. In addition, the industry is characterised by interdependence in the Squid supply line which indicates the measure of risk for SMEs and HDIs in which the export price of Squid plays a significant role. Pursuant to this, the effects of the depressed export price on SMEs and HDIs are both direct and indirect and impair their competitiveness.

SASEA has therefore approached the Commission with a proposed arrangement to disseminate sensitive market related information to its members in order to prevent an impairment of the export price. In terms of the arrangement, SASEA will verify the information submitted by SASEA members and ensure that it is centrally available without identifying the relevant member. This information will be available for SASEA members in determining their own independent business decisions.

Specifically, SASEA has requested that it be permitted to engage in the following activities to achieve its objectives:

- Membership to SASEA and hence the ability obtain market related information will not be exclusive and any South African Squid exporter may become a member.
- Real time information in the December/January/February season on daily volumes of Squid actually caught by SASEA members, estimated catches for the season, estimated stocks still available for the season, daily quoted export price by each member, daily achieved price by each member and the export country of destination in each sale.

- The information given above collated during the entire season on a weekly basis from any source.
- Appoint an independent person to verify and disseminate the information and ensure anonymity for all information circulated amongst SASEA members.
- Allow member to use the information given above in respect of their own independent business decisions including squid prices and inventory.

SASEA submits that the agreements between its members with the intention of collation and dissemination of market related information would contravene Section 4(1)(b)(i) and (ii) of the Competition Act which is a *per se* prohibition that cannot be defended on efficiency, technological or pro-competitive grounds. SASEA avers that the above conduct is however necessary to attain the objectives stipulated under Section 10(3)(b) of the Competition Act, namely, that such an arrangement between its members would contribute to one or all of the following objectives:

- i. The maintenance or promotion of exports; and
- ii. The promotion of the ability of small business or firms controlled or owned by historically disadvantaged persons, to become competitive.

In accordance with the provisions of Section 10(6)(a) of the Competition Act, notice is hereby given of the above application for exemption. An application for an exemption from the provisions of the Competition Act 89 of 1998, as amended ("the Competition Act") has been filed with the Competition Commission of South Africa ("the Commission") in terms of section 10(1)(a) of the Competition Act, by Oceana Lobster Limited; Premier (Pty) Ltd; Ruwekus, (Pty) Ltd, Ovenstone (Pty) Ltd and African Marine Products (Pty) (hereinafter collectively referred to as "the Applicants").

The Applicants are South African companies that operate in fishery sector and are active in the catching, processing, marketing and / or exporting of one or more of these fish species; South Coast Rock Lobster, West Coast Rock Lobster and Tristan Lobster ("lobster"). The Applicants market and export ninety nine (99) per cent of their produce into foreign markets.¹

The application for the exemption is in respect of practices by the Applicants in terms whereof they would engage in co-ordinated sharing of detailed price sensitive information for the marketing and sale of lobster in foreign markets. The Applicants submit that in order for the South African lobster market to continue to be viable export driven industry it is necessary for the Applicants to co-ordinate their marketing strategies in respect of sales into certain international markets. In particular the Applicants want to be permitted to engage in the activities listed below, which activities are proscribed by the Competition Act:

- Meetings and communications between producers and marketers of lobster in order to share knowledge in respect of market conditions and stabilise international selling prices;
- Engage collectively in advance of marketing trips in order to communicate progress, insights and past results with particular purchasers; and
- Coordination and/or collaboration in respect of marketing, in particular, the shared use of marketing agents.

The exemption is sought for a period of ten years.

The Applicants submit that the conduct for which exemption is sought, would contravene the sections 4(1)(a) and 4(1)(b)(i) of the Competition Act which is a per se prohibition that cannot be defended on efficiency, technological or pro-competitive grounds. The Applicants aver that the above conduct is necessary to obtain one of the objectives set out in section 10(3)(b) of the Competition Act, in particular, that such co-ordination and information sharing would contribute to the maintenance and promotion of exports.²

In accordance with the provisions of section 10(6)(a) of the Competition Act, notice is hereby given of the above application for exemption. Interested parties can make written submissions to the Commission as to why the exemption should not be granted as required by section 10(6)(b) of the Competition Act. 

1. Introduction

1.1 Policy context

One of the key strategic issues for the health sector 10 Point Plan is "improving the quality of health services", and the Strategic Plan for the department 2011/15 reflects the need to strengthen the provision of environmental health services in the country. The shift of focus from prevention to a curative health system has impacted negatively on the health status of the country as people depended on the health system for their wellbeing rather than themselves. Government recognises the importance of prevention across all areas of health care, which are clearly indicated in the White Paper on the Transformation of Health Services, as well as the Primary Health Care alma-ata.

The Draft National Policy on Environmental Health Services reflects the Government's intent as far as rendering Environmental Health Services is concerned. It is subject to the broader National Health Policy, as set out in the White Paper on the Transformation of Health Services in South Africa.

1.2 Legal context

The National Health Act, 61 of 2003 stipulates the broad role of national health to issue and promote adherence to norms and standards on health matters, including environmental conditions that constitute a health hazard. The act further stipulates and provides Environmental Health Practitioners with the powers to enter any premises, except for a private dwelling, at any reasonable time and inspect such premises, in order to ensure compliance with the act. Only a health officer registered as an Environmental Health Practitioner in terms of the Health Professions Act, 1974 (Act 56 of 1974) may conduct environmental health investigations, in terms of section 83 of the National Health Amendment Bill, 2011. The section states that if a health officer has reasonable grounds to believe that any condition exist which –

- a. Constitute a violation to the right contained in section 24(s) of the Constitution;
- b. Constitute pollution detrimental to health;
- c. Is likely to cause a health nuisance; or
- d. Constitutes a health nuisance, the officer must investigate such condition.

EHPs may further issue a compliance notice to any person if a provision in the National Health Act has not been complied with.

The Regulations defining the Scope of the Profession of Environmental Health outlines functions of Environmental Health Practitioners as the Nine Municipal Health functions. In terms of the National Health Act, Municipal Health Services are defined to include the following environmental health functions, which are provided by District and Metropolitan Municipalities:

1. Water quality monitoring;
2. Food control;

3. Waste management;
4. Health surveillance of premises;
5. Surveillance and prevention of communicable diseases, excluding immunizations;
6. Vector control;
7. Environmental pollution control;
8. Disposal of the dead; and
9. Chemical safety.

Provincial Environmental Health Services which are provided directly by the Provincial Departments of Health are:

- a. Malaria Control; and
- b. Control of Hazardous Substances.

The National Health Amendment Bill amended the general functions of the national department of health to include the facilitation and promotion of Port health service, which was assigned as a provincial health function in terms of the NHA 2003. This function will become a national competency, due to the fact that it is an international service which is governed by the International Health Regulations, of which South Africa is a signatory. Therefore the service is best managed at national government level.

2. Purpose of the Norms and Standards

The norms and standards for environmental health will assist in setting a benchmark of quality against which delivery of environmental health services can be monitored.

The main purpose of the norms and standards is to provide a national approach in ensuring standardization of functions and activities in the delivery of environmental health services and establish a level against which environmental health service delivery can be assessed and gaps identified.

This environmental health norms and standards will be aligned to the norms and standards for health establishments as published by the Office of the Health Standards Compliance.

3. Background and structure of the Norms and Standards

These National Norms and Standards reflect the South African policy context and are based to a large extent on existing legislation, policies, guidelines, protocols related to environmental health, including those for which custodianship lies with other government departments such as the Department of Environmental Affairs, Department of Water Affairs, Social Development and the South African Bureau of Standards, etc. The standards embody what Environmental Health Practitioners are expected to do in delivering functions as per the Scope of Profession, and as well as requirements for other sectors, such as business, public sector, private and public owned or occupied premises in order to comply with legislation for protection of public health.

The focus areas for these standards includes the Health Surveillance of Premises (which includes vector control, food safety, environmental pollution control, noise control, points

of entries and disposal of the dead), Health related Water Quality Monitoring and Waste management. These particular standards do not cover chemical safety, hazardous substances and communicable diseases control, although these standards will be developed over time. The standards are structured in chapters/functional areas:

Chapter 1: Norms and standards for **health surveillance of premises**, which scope of applicability covers ‘premises’ as defined in the National Health Act 61 of 2003 and set out the requirements for each premises to ensure compliance with legislation and also set out standards for environmental health monitoring by EHPs.

Chapter 2: Norms and Standards for **Port health**, which covers requirements for points of entries, ships and aircrafts

Chapter 3: Norms and Standards for **health related water quality monitoring**, which covers specific services essential in monitoring the quality of water by Environmental Health Practitioners for various settings and situations, as well as specifications for the quality of water.

Chapter 4: Norms and standards for **waste management**, which covers requirements for hazardous and general waste and monitoring requirements for EHPs.

Each chapter includes an index which guides the sections within the chapter.

Chapter 5: Norms and standards for **hazardous substances and chemicals management**, whose scope of applicability covers the storage, labeling, packaging and disposal of chemicals and hazardous substances.

4. The use of the Norms and Standards

The over-riding goals of these norms and standards are to assist in improving the provision of environmental health services in the country by EHPs and promoting compliance to environmental health related legislation by all. The primary activity therefore is to ensure that these standards are disseminated to all EHPs, particularly functional EHPs based at District and Metropolitan Municipality, Points of Entries and Provincial Departments of Health, as well as to the general public, and that adherence to these standards becomes a norm.

5. Monitoring and enforcing compliance with standards

Municipalities, provinces and Points of Entries can conduct self assessments to provide a baseline on the quality of EHS provided to the general public, provinces can also assess the Municipalities delivery of services. However, to ensure compliance with the National Norms and Standards, the National Department of Health will conduct environmental health service delivery assessments to rate the quality of EH services provided and to ensure adherence to the prescribed standards. A gap analysis will be conducted to identify gaps, strengths and opportunities in the provinces. The monitoring and enforcement of the prescribed norms and standards by environmental health will also be done in collaboration with the office of the Health Standards Compliance for monitoring of prescribed environmental health standards in health establishments.

The International Trade Administration Commission (herein after referred to as ITAC or the Commission) has received the following applications concerning the Customs Tariff. Any objection to or comments on these representations should be submitted to the Chief Commissioner, ITAC, Private Bag X753, Pretoria, 0001. Attention is drawn to the fact that the rate of duty mentioned in these applications is that requested by the applicant and that the Commission may, depending on its findings, recommend a lower or higher rate of duty.

CONFIDENTIAL INFORMATION

The submission of confidential information to the Commission in connection with customs tariff applications is governed by section 3 of the Tariff Investigations Regulations, which regulations can be found on ITAC's website at <http://www.itac.org.za/documents/R.397.pdf>.

These regulations require that if any information is considered to be confidential, then a non-confidential version of the information must be submitted, simultaneously with the confidential version. In submitting a non-confidential version the regulations are strictly applicable and require parties to indicate:

- Each instance where confidential information has been omitted and the reasons for confidentiality;*
- A summary of the confidential information which permits other interested parties a reasonable understanding of the substance of the confidential information; and*
- In exceptional cases, where information is not susceptible to summary, reasons must be submitted to this effect.*

- 1. Increase in the domestic Dollar-based reference price (DBRP) for sugar classifiable under tariff heading 17.01 from US\$358/ton to US\$764/ton through an adjustment of the calculation of the DBRP for sugar by basing it on the domestic cost of production.**

Using the requested reference price of US\$764/ton, the variable tariff formula for sugar will trigger an increase if the London No. 5 sugar settlement price falls by US\$20/ton below the base price, which is the 3-week moving average price for the London No. 5 sugar settlement price. Conversely, a reduction in the duty will be triggered if the London No. 5 sugar settlement price increases by US\$20/ton above the base price.

AS REASONS FOR THE APPLICATION THE APPLICANT STATED THAT:

The main motivation for an adjustment in the SACU tariff on imported sugar is to have a fair level of protection which can be justified on the following basis:




REASONS FOR THE WITHDRAWAL:

Fima Films indicated that as a result of the change in the management structure, a new strategy which differs from that of the previous management was developed. The new management has considered the application for increase in the rate of duty and decided that it would not be beneficial for the company owing to the negative response received from the downstream industry opposing the application.

CALL FOR THE NOMINATION OF CANDIDATES FOR THE NATIONAL INTELLECTUAL PROPERTY MANAGEMENT OFFICE DISPUTE PANEL

The Minister of Science and Technology hereby invites interested parties to nominate candidates to be considered for appointment to the National Intellectual Property Management Office (NIPMO) Dispute Panel for a period not exceeding four years.

NIPMO was established to promote the objects of the Intellectual Property Rights from Publicly Financed Research and Development (IPR-PFRD) Act, 2008, namely "*to ensure that intellectual property emanating from publicly financed research and development is identified, protected, utilised and commercialised for the benefit of the people of the Republic, whether it be for a social, economic, military or any other benefit*".

Regulation 7 of the regulations published under the IPR-PFRD Act provides for the Minister of Science and Technology to establish a dispute panel to hear and determine disputes relating to the administrative decisions of NIPMO. The dispute panel will consist of no less than five and no more than 20 members, who must have experience and expertise in areas relating to the protection, management and commercialisation of intellectual property, dispute resolution and business.

Members of the panel should be South African citizens or have the right of permanent residence in the country. The members will be drawn from diverse backgrounds and institutions in order to minimise potential conflicts of interest.

The dispute panel will be accountable to the Minister. It must establish its own rules of procedure, which NIPMO must publish, and make decisions applying the principles of fairness, justice and reasonableness. Allowances will be paid in accordance with National Treasury guidelines. The shortlisted candidates will undergo the Department's standard screening.

Nominations should be submitted to the Minister of Science and Technology no later than **30 September 2013**. They must be accompanied by the following:

- Relevant curricula vitae for nominated candidates, including the following information, must accompany nominations: identity number; gender; race; job title and description; contact details (postal and email addresses and telephone and fax numbers); qualifications and field; current and past service on boards; areas of expertise; names and contact details of three referees.
- Confirmation of the availability of the nominee.
