AMOUNT PAYABLE BY A DRIVING LICENCE TESTING CENTRE IN TERMS OF REGULATIONS 108 (1A) AND 119 (1A) OF THE NATIONAL ROAD TRAFFIC REGULATIONS, 2000 UNDER THE NATIONAL ROAD TRAFFIC ACT, 1996 (ACT 93 OF 1996)

I, **Dipuo Peters**, Minister of Transport, acting in terms section 75 of the National Road Traffic Act, 1996 (Act No. 93 of 1996) read with regulations 108 (1A) and 119 (1A) of the National Road Traffic Regulations, 2000 do hereby intend to increase the amount that a driving licence testing centre shall pay over to the Card Production Facility as contemplated in the said regulations, as being R 79, 00 for every issuance of a driving licence card or professional driving permit, the application of which is received on or after 1 November 2013.
