

## CALL FOR NOMINATION AS COUNCIL MEMBERS

In terms of the RULES FOR THE PROCEDURES OF NOMINATION OF SACQSP COUNCIL MEMBERS as promulgated on the 12<sup>th</sup> July 2013, we hereby call for nominations for members of the public, academics lecturing within QS accredited programs, state employees, members of the voluntary association who are all registered professional quantity surveyors, plus interested public participants to be appointed as members of the South African Council for the Quantity Surveying Profession (SACQSP).

In terms of the Quantity Surveying Profession Act, 2000 (Act No. 49 of 2000), vacancies for the following nominees exist;

Professional representation	-	9
State representation	-	3
Academia	-	2
Public representation	-	3

### Background

In December 2000, the President assented to legislation providing for the establishment of Council for the Quantity Surveying profession. The Council was established in August 2001 and replaced the previous statutory Council and board for the profession. The Council registers professionals and candidates in their profession, accredits educational institutions, upholds professional conduct, identifies the functions of the profession, recommends professional fees and promotes regional and international recognition of the profession.

The Council will meet at least twice a year and will be supported by administrative staff.

The period of office for the members is four years.

Each nomination must be in writing with the information in the detail required by the Council as laid out on the prescribed acceptance form downloadable from the SACQSP website. [www.sacqsp.org.za](http://www.sacqsp.org.za)

All nominations, duly completed and signed, must be submitted to the Council (**Attention: The Registrar**) at the address provided by no later than 12h00 1<sup>st</sup> December 2013. Incomplete nominations and nominations received after this date will not be considered.
