APPLICATION FOR A TRANSFER OF AN INDIVIDUAL COMMERCIAL SOUND BROADCASTING SERVICE LICENCE FROM KAGISO BROADCASTING (PTY) LTD TO KTH MEDIA INVESTMENTS (PTY) LTD IN RESPECT OF EAST COAST RADIO

1. The Independent Communications Authority of South Africa (“the Authority”) hereby gives notice that it has received an application from Kagiso Broadcasting (Pty) Ltd for a transfer of its Individual Commercial Sound Broadcasting Service Licence in respect of East Coast Radio. This application is lodged in terms of regulation 11 of the Processes and Procedures Regulations for Individual Licences and Special Temporary Authorisations of 2010 read with sections 13(1) and (2) of the Electronic Communications Act, No. 36 of 2005.
2. The transfer application seeks the approval from the Authority to transfer the Individual Commercial Sound Broadcasting Service Licence from Kagiso Broadcasting (Pty) Ltd to KTH Media Investments (Pty) Ltd.
3. The application, relevant schedule and any representations received pursuant thereto would be made available and open for inspection by interested parties in the Authority’s library during the Authority’s normal office hours.
4. Interested parties are invited to lodge written representations in relation to the application within twenty one (21) working days of the date of publication of this notice.

5. Persons who make such representations must indicate in their written representations whether they require an opportunity to make oral representations in the event the Authority decides to hold public hearings.

Kagiso Broadcasting (Pty) Ltd shall be entitled to respond in writing to written representations made by interested persons on the transfer application, and such written response must be lodged with the Authority within forty two (42) working days of the date of publication of this notice in the *Government Gazette*. Kagiso Broadcasting (Pty) Ltd must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, **OR** has sent a copy of such response by registered mail **OR** by facsimile **OR** by e-mail to the relevant person having made such written representations.
