## INVESTIGATION INTO THE FUNERAL UNDERTAKING SECTOR, SOUTH AFRICA WITH A VIEW TO ESTABLISH A SECTORAL DETERMINATION PRESCRIBING MINIMUM WAGES AND CONDITIONS OF EMPLOYMENT.
