APPLICATIONS FOR TRANSFER OF AN INDIVIDUAL ELECTRONIC COMMUNICATIONS NETWORK SERVICE AND INDIVIDUAL ELECTRONIC COMMUNICATIONS SERVICE LICENCES FROM WESTSIDE TRADING TO SAAB GRINTEK TECHNOLOGIES (PTY) LTD

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received applications from Westside Trading for transfer of its Individual Electronic Communications Network Service (I-ECNS) and Individual Electronic Communications Service (I-ECS) licences. The applications was lodged in terms of regulation 11 of the Processes and Procedures Regulations for Individual Licences and Special Temporary Authorisations of 2010 read with sections 13(1), (2) and (6) of the Electronic Communications Act, as amended.
2. The transfer applications seek the approval from the Authority to transfer the I-ECNS and I-ECS licences from Westside Trading to Saab Grintek Technologies (Pty) Ltd.

5. Persons who make such representations must indicate in their written representations whether they require an opportunity to make oral representations in the event the Authority decides to hold public hearings.

Westside Trading shall be entitled to respond in writing to written representations made by interested persons on the transfer applications, and such written response must be lodged with the Authority within forty two (42) working days from the date of publication of this notice in the Government Gazette. Westside Trading must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, OR has sent a copy of such response by registered mail OR by facsimile OR by e-mail to the relevant person having made such written representations.
