# PRELIMINARY ALLOCATION SCHEDULE FOR COMPULSORY LICENSING PUBLISHED IN TERMS OF S46 (1) OF THE NATIONAL WATER ACT NO. 36 OF 1998, FOR S21 (a), (b) and (d) WATER USE IN THE MHLATHUZE CATCHMENT

I, Anil Bijman Singh, as the delegated authority in terms of section 63(1) of the National Water Act, 1998 (Act No. 36 of 1998) ["the Act"] have completed a preliminary allocation schedule for the Mhlathuze Catchment in terms of section 46(1) of the Act. A summary of the quantity of water been allocated is set out in the Annexure hereto.

In terms of section 46(1) (a) of the Act, the preliminary allocation schedule can be inspected at the addressed set in a table herein.

In terms of section 46(1) (b) read with Chapter 15 of the Act, affected and interested parties may make appeals to the Water Tribunal against the decision published in the preliminary allocation schedule. However, in light of the fact that the term of the office of the Chairperson of the Water Tribunal has since expired the Department is in the process of appointing the Chairperson of the Water Tribunal, and until the Chairperson has been appointed all appeals will be resolved in terms of section 150. Affected and interested parties who unsuccessfully lodged objections to the proposed allocation schedule that was published by the Department of Water and Sanitation on the 10 August 2012 and wish to appeal must submit their written appeals/within 30 days of the publication of this notice as follows:-
