

EMBLEM: (The Chief Justice) On a background Argent, a laurel wreath Or, in base surmounting an open book edged Or, bound Brunâtre, on the pages the upper third of the national flag displayed vertically; statant upon the upper edge of the book the Scales of Justice Or, ensigned of a faceted demi-sun of nine rays issuant Argent and Or; the whole within a fillet annulet Or, there within an annulet Argent, edged Or, bearing the words THE CHIEF JUSTICE in chief, and in base REPUBLIC OF SOUTH AFRICA in letters Or.
