SECTION 43 OF THE FURTHER EDUCATION AND TRAINING COLLEGES ACT, 2006 (ACT NO. 16 OF 2006)

PROVISIONAL APPROVAL ON THE OFFERING OF HIGHER EDUCATION
QUALIFICATIONS PUBLIC TECHNICAL AND VOCATIONAL
EDUCATION AND TRAINING COLLEGES UNDER THE AUTHORITY OF
HIGHER EDUCATION INSTITUTIONS

I, Bonginkosi Emmanuel Nzimande, Minister of Higher Education and Training, hereby, in terms of Sections 43(3) and 43(4) of the Further Education and Training Colleges Act, 2006 (Act No 16 of 2006) grant provisional approval to public Technical and Vocational Education and Training Colleges to provide higher education qualifications under the authority of higher education institutions as set out in **Schedule A.** 

Only qualifications that comply with the criteria in terms of the *Higher Education Qualifications Sub-Framework (HEQSF) in Government Gazette 36721, dated 2 August 2013*, which form part of the *Programmes and Qualifications Mix (PQM)* for higher education institutions, and which are accredited by the Council on Higher Education (CHE), are considered for approval.

Colleges that receive provisional approval through this Government Gazette must. within a period of six (6) months from the date of publication hereof comply with all requirements as set out in the letter granting the college permission in terms of section 43(4)(a) of the Further Education and Training Act. 2006. Failure to comply will cause the names of the colleges and the corresponding qualifications to be removed from the Schedule, subject to fair administration of justice. This Government Gazette repeals Government Notice No 33856, dated 9 December 2010.

# **SCHEDULE A**

The following public Technical and Vocational Education and Training (TVET) colleges are granted provisional approval to provide higher education qualifications under the authority of higher education institutions in the listed qualifications.
