

#### **GPW Business Rules**

1. No hand written notices will be accepted for processing, this includes Adobe forms which have been completed by hand.



- 3. Notices brought into GPW by "walk-in" customers on electronic media can only be submitted in Adobe electronic form format. This means that any notice submissions not on an Adobe electronic form that are submitted by the customer on electronic media will be <u>rejected</u>. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
- 4. All customers who walk in to GPW that wish to submit a notice that is not on an electronic Adobe form will be routed to the Contact Centre where the customer will be taken through the completion of the form by a GPW representative. Where a customer walks into GPW with a stack of hard copy notices delivered by a messenger on behalf of a newspaper the messenger must be referred back to the sender as the submission does not adhere to the submission rules.

# PUBLIC NOTICE IN TERMS OF SECTION 12 OF THE ELECTORAL ACT, 73 OF 1998

The applications for registration or re-registration, as per the schedule below, for enrolment into the segment of the voters' roll for voting district number 32950087 (Laerskool Booysens) have been refused on the basis that the applicants are not ordinarily resident in the voting district in which they have applied for registration as voters. Should any applicant in the schedule be aggrieved by this decision, he or she may appeal to the Commission in terms of Section 13 of the Electoral Act. Such appeals and supporting evidence must reach the Commission before 22 July 2015 at Election House, 1303 Heuwel Road Centurion.
