## MEDICINES AND RELATED SUBSTANCES ACT 101 OF 1965 AS AMENDED

**Definitions:**

- "the Act" means the Medicines and Related Substance Act (Act 101 of 1965)
- "the Council" means the Medicines Control Council.

The Medicines Control Council, in terms of Section 23(1)(b) of the Act, is of the opinion that it is not in the public interest that **the products listed below**, not registered with the Council, be made available to the public, and has declared these medicine undesirable

The Council further directs any person who has in his or her possession any quantity of **the products listed below** to return them to the manufacturer thereof or to the importer concerned.
