Notice submission deadlines

Government Printing Works has over the last few months implemented rules for completing and submitting the electronic Adobe Forms when you, the customer, submit your notice request.

In line with these business rules, GPW has revised the notice submission deadlines for all gazettes. Please refer to the GPW website www.gpwonline.co.za to familiarise yourself with the new deadlines.

CANCELLATIONS



Cancellation of notice submissions are accepted by GPW according to the deadlines stated in the table above. Non-compliance to these deadlines will result in your request being failed. Please pay special attention to the different deadlines for each gazette.

Please note that any notices cancelled after the cancellation deadline will be published and charged at full cost.

Requests for cancellation must be sent by the original sender of the notice and must accompanied by the relevant notice reference number (N-) in the email body.

AMENOMENTS TO NOTICES



With effect <u>from 01 October</u>, GPW will not longer accept amendments to notices. The cancellation process will need to be followed and a new notice submitted thereafter for the next available publication date.

CUSTOMER INQUIRIES



Many of our customers request immediate feedback/confirmation of notice placement in the gazette from our Contact Centre once they have submitted their notice – While GPW deems it one of their highest priorities and responsibilities to provide customers with this requested feedback and the best service at all times, we are only able to do so once we have started processing your notice submission.

GPW has a <u>2-working day turnaround time for processing notices</u> received according to the business rules and deadline submissions.

Please keep this in mind when making inquiries about your notice submission at the Contact Centre.

PROOF OF PAYMENTS REMINDER

GPW reminds you that all notice submissions **MUST** be submitted with an accompanying proof of payment (PoP) or purchase order (PO). If any PoP's or PO's are received without a notice submission, it will be failed and your notice will not be processed.

When submitting your notice request to submit.egazette@gpw.gov.za, please ensure that a purchase order (GPW Account customer) or proof of payment (non-GPW Account customer) is included with your notice submission. All documentation relating to the notice submission must be in a single email.

A reminder that documents must be attached separately in your email to GPW. (In other words, your email should have an Adobe Form plus proof of payment/purchase order – 2 separate attachments – where notice content is applicable, it should also be a 3rd separate attachment).

REMINDER OF THE GPW BUSINESS RULES

- ☐ Single notice, single email with proof of payment or purchase order.
- ☐ All documents must be attached separately in your email to GPW.
- 1 notice = 1 form, i.e. each notice must be on a separate form
- ☐ Please submit your notice **ONLY ONCE.**
- Requests for information, quotations and inquiries must be sent to the Contact Centre ONLY.
- The notice information that you send us on the form is what we publish. Please do not put any instructions in the email body.

NOTICE OF THREE SOCIAL WORKERS DULY ELECTED AND THAT THREE ADDITIONAL SOCIAL WORKERS MUST STILL BE ELECTED TO SERVE ON THE SACSSP IN TERMS OF THE SOCIAL SERVICE PROFESSIONS ACT 1978, AS AMENDED

Under the provision of regulation 5(i) (a);(3) of the Regulations regarding the election and appointment of members of the South African Council for Social Service Professions (SACSSP), notice is herewith given that 10 nominations were received of which 6 were rejected due to them not meeting the requirements, so the remaining 4 candidates were initially found to be duly elected during the first call for nominations dated <u>02</u> <u>October 2015</u>. Because one nominee was also elected to serve on the Professional Board for Social Work (PBSW) this appointment was only confirmed in February 2016; hence in terms of section 9 (1) the three remaining members are regarded as duly elected because the number of persons accepted as candidates are <u>equal to or less</u> than the number of members to be elected"; A bona fide error was made when these names were published on the ballot paper, however should any votes be received for any of these members it will not be considered as they are already elected.

The prolonged decision of the one member caused delays in the finalisation of the elections of the Council, as well as the publication of PBSW election results as she was given since November 2015 the opportunity to choose between serving on the Council or PBSW as she would not be allowed to serve on both structures during the same term of office.

On 27 October 2015 during the second call two nominations were requested but more was received; which necessitated elections. In view of the one member confirmed to be a PBSW member and terms section 9 (2) (a) **three additional members** are to be elected and the closing date has been extended until **16 March 2016** to ensure that persons who might have received mail late due to postal delays and returned mail that was resend are not disadvantaged.

These results could not be published as one member who was also nominated to serve on the Council was afforded the opportunity since November 2015 to decide the structure she would wish to serve on as she would not be allowed to serve on both structures (Council and PBSW) during the same term of office and in only February 2016 was she notified of the final decision that her first election on the PBSW is regarded as confirmed in order to avoid further delays with the finalisation of the elections of the Council and with the publication of the election results of the PBSW.
