FERTILIZERS, FARM FEEDS, AGRICULTURAL REMEDIES AND STOCK REMEDIES ACT, 1947 (ACT NO. 36 OF 1947)

PROHIBITION ON THE IMPORT, EXPORT, POSSESSION, ACQUISITION, SALE, USE AND DISPOSAL OF AGRICULTURAL REMEDIES

- I, Senzeni Zokwana, Minister of Agriculture, Forestry and Fisheries acting under section 7bis of the Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act, 1947 (Act No. 36 of 1947), hereby prohibit the acquisition, import, export, possession, sale, use and disposal of agricultural remedies which contains:
 - i. Aldicarb
 - ii. Aldrin
 - iii. Azinphos-ethyl
 - iv. Binapacryl
 - v. Camphechlor (CLC)
 - vi. Captafol
 - vii. Chlordimeform
 - viii. Chlorobenzilate
 - ix. Dibromochloropropane
 - x. Dinitro-ortho-cresol (DNOC)
 - xi. Dinoseb
 - xii. Endrin
 - xiii. Heptachlor
 - xiv. Hexachlorobenzene
 - xv. Kepone
 - xvi. Phosphamidon
 - xvii. Phosphorous containing formulations
 - xviii. Propham
