I, Sakhumzi Somyo, Member of the Executive Council Responsible for Economic Development, Environmental Affairs and Tourism in the Province of the Eastern Cape, acting in terms of section 12(5)(b) of the Nature and Environmental Ordinance 1974 (Ordinance No.19 of 1974) read together with section 24(2) of the National Environmental Management: Protected Areas Act, 2003 (Act No. 57 of 2003) hereby:

- (a) withdraw Notice No. 341 of 1992 establishing the private nature reserve known as the "Kaapse Grysbok Nature Reserve" constituted by Portion 1 and the remainder of the farm, Grassridge 190, in the Nelson Mandela Bay Metropolitan Municipality, published in the Official Gazette of the Province of the Cape of Good Hope 4759 of 17 July 1992, and
- (b) abolish the aforementioned private reserve.
