ELECTRONIC COMMUNICATIONS ACT, 2005 (ACT NO. 36 OF 2005) REGULATIONS

The Independent Communications Authority of South Africa has, under section 8 read with section 4 of the Electronic Communications Act, 2005 (Act No. 36 of 2005), as amended, and section 17E(2)(b) of the ICASA Act, 2000 (Act No. 13 of 2000) made the regulations in the schedule.

SCHEDULE 1

Definitions

1. In this notice "the Regulations" means the regulations published by Government Notices No. 523 of 2010 and No. 158 of 2016.

Repeal of regulation 2 (1A) of schedule 2 of the Regulations

2. Regulation 2 (1A) of schedule 2 of the Regulations is hereby repealed.

Repeal of regulation 2 (1A) of schedule 3 of the Regulations

3. Regulation 2 (1A) of schedule 3 of the Regulations is hereby repealed.
