

NOTICE OF INTENTION TO INTRODUCE THE ROAD ACCIDENT BENEFIT SCHEME BILL, 2017 INTO PARLIAMENT IN TERMS OF THE RULE 241(1) (b) OF THE NATIONAL ASSEMBLY

The Minister of Transport hereby in terms of National Assembly Rule No.241(1) (b) intends introducing the Road Accident Benefit Scheme Bill, 2017 ("the Bill") in Parliament during 2017.

The Bill and its Explanatory Memorandum were published for a comment in Government Gazette No. 36138 dated 08 February 2013 and is called the Road Accident Benefit Scheme Bill, 2017.

The object of the Bill is as follows:-

To provide for a social security scheme for the victims of road accidents; to establish the Road Accident Benefit Scheme Administrator to administer and implement the scheme; to provide a set of defined benefits on a no-fault basis to persons for bodily injury or death caused by or arising from road accidents; to exclude liability of certain persons otherwise liable for damages in terms of the common law; and to provide for matters connected therewith.
