PROPOSED FEES PAYABLE IN RESPECT OF APPLICATIONS AND THE ISSUING OF RIGHTS,
PERMITS AND LICENCES IN THE SMALL-SCALE FISHERY SECTOR

1. I, Senzeni Zokwana, Minister of Agriculture, Forestry and Fisheries intend, acting under Section 25 of the Marine Living Resources Act, 1998 (Act No. 18 of 1998) (the Act), to set out a small-scale fisheries sector fee in the Schedule hereto in consultation with the Minister of Finance.
2. Interested persons are hereby invited to submit written comments regarding the proposed small-scale fishing fee within 30 days of the publication of this Notice.
3. Comments regarding the proposed small-scale fishing fee structure must please be submitted by-
 - (a) e-mailing it to ssfees@daff.gov.za; or
 - (b) posting it to Small-Scale Fishing Fees, Customer Service Centre, DAFF, Fisheries Management, P/Bag X2, Roggebaai 8012; or
 - (c) delivering it by hand at Customer Service Centre, DAFF, Fisheries Management, Foretrust Building, Martin Hammerschlag Way, Cape Town.

SCHEDULE

1. APPLICATION FEES

- (a) Fee payable in respect of an application for a right to –
 - i. Operate a fish processing establishment: R9,123
 - ii. Undertake small-scale fishing: R10 per co-operative member
- (b) Fee payable in respect of an application for a permit to exercise a right granted to –
 - i. Operate a fish processing establishment: R240
 - ii. To undertake small-scale fishing (commercial purposes): R240
 - iii. To undertake small-scale fishing (food security purposes): R10 per co-operative member
- (c) Fees payable in respect of an application for a permit from a holder of a small-scale fishing right to transport any fish or any part or product thereof from any landing point for commercial purposes: R240
- (d) Fees payable in respect of an application for a local fishing vessel license: R240
- (e) Fees payable in respect of an application for a permit or license to perform an activity in terms of the Act not mentioned in paragraphs 1 (b) – (d): R240

2. PERMIT FEES

- (a) Fees payable in respect of the issuing of permits to exercise a right to –
 - i. Undertake small-scale fishing (commercial purposes): R831
 - ii. Undertake small-scale fishing (food security purposes): R0
- (b) Fees payable in respect of the issuing of a permit to a holder of a small-scale fishing permit to transport any fish or any part or product thereof from any landing point for commercial purposes: R265
- (c) Fees payable in respect of the issuing of a permit to perform an activity in terms of the Act not mentioned in paragraphs 2 (a) – (b): R265

3. LICENSE FEES

(a) Fees payable in respect of the issuing of a license for a local fishing vessel with a length of –

i. 5 metres and less:	R269
ii. More than 5 m to 8 m	R375
iii. More than 8m to 10 m	R606
