The Road Accident Fund is a national public entity established for the purpose of paying compensation in accordance with the provisions of the Road Accident Fund Act, 1996 (Act No. 56 of 1996) as amended, for loss or damage wrongfully caused by the driver of motor vehicles within the Republic of South Africa.

The Fund has a Board, whose function, amongst others, is to exercise the overall authority and control over the financial position, operation and management of the Fund. The Board serves for a period of three (3) years and is accountable to the Minister of Transport. The current Board was appointed with effect from 1 October 2016 and its term will expire on the 30 September 2018.

An invitation for nomination was published in the *Gazette* and national news media for nominations of persons to serve on the RAF Board. The deadline for submission of nominations was the 25 June 2017.

As required in terms of section 10(9) (b) of the Road Accident Fund Act, 1996 (Act No. 56 of 1996), the Minister of Transport Mr M.J. Maswanganyi hereby publishes the list of nominations received in response to the invitation, which reflects the names of the nominees together with the nominators.
