Definition

1. In this Schedule, "the existing Notice" means Government Notice 1576 published in Government Gazette No. 40508 of 19 December 2016.

Amendment of item 1 of the Schedule to the existing Notice

2. The words preceding paragraph (a) in Item 1 of the existing Notice are hereby amended as follows:

"1. Vehicles providing the following public transport services and which have been issued with and whose owners are in possession of a valid operating licence or permit issued for the vehicle in question in terms of the National Land Transport Act, 2009 (Act No. 5 of 2009) or recognised by that Act and which are registered with the Agency and have an e-tag issued by the Agency affixed to such vehicle, in accordance with the e-Road Regulations, 2013 and the Exemption and Rebate Regulations as made by the Minister under section 58(1)(dA) and (dC) of the Act,

by no later than **[1 September 2017]** 30 September 2018, provided that a vehicle may be so registered after 30 September 2018 where an operating licence was issued for it after that date:"
