BOARD NOTICE 159 OF 2017**INVITATION TO THE PUBLIC TO NOMINATE SACAP COUNCIL MEMBER (S) TO SERVE ON THE COUNCIL FOR THE ARCHITECTURAL PROFESSION.**

Call for nomination of a member of the public to be appointed to serve as a member of the South African Council for the Architectural Profession (SACAP) in terms of section 3 (1) (c) of the Architectural Profession Act, 2000 (Act, No. 44 of 2000) ("the Act").

When nominating, consideration should be given to representivity in respect of race, gender, disability and geographical location.

BACKGROUND

SACAP is a statutory body established in terms of section 2 of the Act. The Council is mandated by the Act to protect the public by registering professionals and candidates, accrediting education institutions, and regulation of the architectural profession.

The Council meets at least four times a year and is supported by administrative staff. The term of office for Council members is four years.

Each nomination must be in writing and must contain the following information;

1. The name and address of the nominating person or organisation;
2. The name, address, identity number of the nominee;
3. An acceptance form duly completed and signed by the nominee;
4. Motivation for the appointment of the nominee to the Council (not exceeding one page);
5. A short Curriculum Vitae of the nominee (not exceeding two pages);
6. A declaration by the nominee stating that he/she is not disqualified in terms of section 6 (1) of the Act nor has he/she served on the Council for two consecutive terms;
7. The recommended person will be required to provide the Registrar with a copy of the identity document for verification and all other necessary documents.
8. The nomination form must be accompanied by three reference letters, namely: *character reference letter, employment reference letter and general reference letter*;

All nominations must be duly completed, signed and must be submitted to Council within 60 days from the date the invitation was published in the Government Gazette. Nominations should reach SACAP either by hand, email or post at the address details below no later than **18 November 2017 @ 16h00**. No late submissions will be accepted. Incomplete nominations and nominations received after the due date will not be considered.
