CALL FOR WRITTEN SUBMISSIONS FROM STAKEHOLDER BODIES AND MEMBERS OF THE PUBLIC ON THE REPEAL AND REPLACEMENT OF CHAPTER 10 AND ANNEXURE M OF THE REGULATIONS PERTAINING TO THE CONDUCT, ADMINISTRATION AND MANAGEMENT OF THE NATIONAL SENIOR CERTIFICATE EXAMINATION

1. I, Angelina Matsie Motshekga, Minister of Basic Education, hereby, in terms of *section 61(c) and (d) of the South African Schools Act, 1996 (Act. No. 84 of 1996)* give my intention to repeal and replace Chapter 10 and Annexure M of the *Regulations Pertaining to the Conduct, Administration and Management of the National Senior Certificate examination*, promulgated as *Government Notice. No. 1327 in Government Gazette Vol. 522, No. 31680 of 12 December 2008*
2. In view of the above, I therefore invite stakeholder bodies and members of the public to comment on the repeal and replacement of Chapter 10 and Annexure M to the Regulations referred to in Paragraph 1 set out in the attached **Schedule**.
