### Public hearings on Eskom's third Multi-Year Price Determination (MYPD3) Regulatory Clearing Account (RCA) Year 2 (2014/15), Year 3 (2015/16) and Year 4 (2016/17) applications and indicative timelines for the determination process

The National Energy Regulator of South Africa (NERSA) is a regulatory authority established as a juristic person in terms of Section 3 of the National Energy Regulator Act, 2004 (Act No. 40 of 2004). NERSA's mandate is to regulate the electricity, piped-gas and petroleum pipelines industries in terms of the Electricity Regulation Act, 2006 (Act No. 4 of 2006), Gas Act, 2001 (Act No. 48 of 2001) and Petroleum Pipelines Act, 2003 (Act No. 60 of 2003).

NERSA has received Eskom's third Multi-Year Price Determination (MYPD3) Regulatory Clearing Account (RCA) Year 2 (2014/15), Year 3 (2015/16) and Year 4 (2016/17) applications totalling R66.6 billion.

The Energy Regulator will assess Eskom's application following due regulatory processes. The indicative timeline for the decision-making process is provided in Table 1 below.

2. Closing date for stakeholder comments	23 March 2018
3. Public Hearings on RCAs – 2 <sup>nd</sup> , 3 <sup>rd</sup> & 4 <sup>th</sup> year MYPD3 (9 provinces in 3 weeks)	16 April -11 May 2018 (see details in Table 2)
4. NERSA's Electricity Subcommittee (ELS) to consider draft Reasons for Decision	14 June 2018
5. Energy Regulator decision on Eskom's RCA applications	21 June 2018
