

## APPLICATION FOR THE AMENDMENT OF AN INDIVIDUAL COMMERCIAL SOUND BROADCASTING SERVICE BY PRIMEDIA (PTY) LTD IN RESPECT OF 94.5 KFM.

- 1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received an application from Primedia (Pty) Ltd to amend its 94.5 KFM Individual Commercial Sound Broadcasting Service Licence lodged in terms of Regulation 9 of the Processes and Procedures Regulations for Individual Licences and Special Temporary Authorisations,2010 as amended, read with section 10 of the Electronic Communications Act, No 36 of 2005 ("EC Act").
- 2. The application for amendment and any representations received pursuant thereto, save for information that has been declared confidential in terms of section 4D of the Independent Communications Authority Act No. 13 of 2000 ("ICASA Act"), will be made available for inspection by interested parties in the Authority's library during the Authority's office hours.
- 3. Any interested party is invited to lodge written representations in relation to the application within fourteen (14) working days of the date of publication of this notice in the *Government Gazette*.
- 4. Any person who makes a written representation must indicate whether they require an opportunity to make oral submissions should the Authority decide to hold a public hearing in respect of the application.

- 7. Primedia (Pty) Ltd shall be entitled to respond in writing to written representations made by any interested person on the application, and such written response must be lodged with the Authority within twenty-one (21) working days of the date on which the representation is received.
- 8. Primedia (Pty) Ltd must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by email to the relevant person having made such written representation.
