SOUND BROADCASTING SERVICE LICENCE BY NORTH WEST FM (PTY) LTD**

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received an application from North West FM (Pty) Ltd ("the Applicant"), for the transfer of its Individual Commercial Sound Broadcasting Service Licence lodged in terms of Regulation 11 of the Processes and Procedures Regulations for Individual Licences and Special Temporary Authorisations of 2010 as amended read with section 13 of the Electronic Communications Act No. 36 of 2005 as amended ("the EC Act").
2. The Applicant seeks approval from the Authority to transfer its Individual Commercial Sound Broadcasting Service Licence to Motswako Media Group (Pty) Ltd ("the Transferee") and will be evaluated on the basis of the following criteria:
 - a. Promotion of competition in the ICT sector;
 - b. Interests of consumers; and
 - c. Equity ownership by HDP's.
3. The Applicant asserts that the Transferee meets the legislative requirement of a minimum of 30% of equity being held by Historically Disadvantaged Persons (HDPs) as required in terms of section 9(2)(b).
4. The application, relevant schedule and any representations received pursuant thereto will be made available and be open for inspection by interested parties in the Authority's library during the Authority's office hours.
5. Interested parties are invited to lodge written representations in relation to the application within fourteen (14) working days of the date of publication of this notice in the *Government Gazette*.

6. Any person who makes written representations must indicate whether they wish to make oral submissions should the Authority decide to hold a public hearing in respect of the application.
7. 8. 9. The Applicant shall be entitled to respond in writing to written representations made by interested persons on the transfer application. The written responses must be lodged with the Authority within twenty-one (21) working days after receipt of the written representations.

The Applicant must, at the time of lodging the written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, **or** has sent a copy of such response by registered mail **or** by email to the relevant person having made such written representations.
