1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has in its custody, confiscated equipment, in terms of the Type Approval Regulations 2013 ("the Regulations"), and that cannot be type-approved as envisaged by section 35 of the Electronic Communications Act, 36 of 2005 ("ECA"). The Authority further gives notice that it intends to dispose of equipment confiscated in terms of the Regulations.
2. The said equipment was confiscated by ICASA Inspectors between the year 2000 and June 2018.
3. This Notice seeks to invite all parties whose equipment has been confiscated for non-compliance with the Regulations to make written representations and motivate why such equipment should not be disposed of, within 14 days of publication of this Notice.
4. When making written representation, parties are required to present a copy of confiscated receipt issued by the ICASA Inspector and/or a certificate of compliance issued by the Authority in terms of the Regulations.
5. Any written representations from the affected stakeholders must be made during the Authority's office hours i.e. 8:00 to 16:30.

8. No other claim for confiscated equipment in terms of the Regulations or late written representation will be entertained and allowed after this this process.
