1. 

The SABC shall be entitled to respond in writing to the written representations made by any interested persons, and such written response must be lodged with the Authority within twenty-one (21) working days of the publication of this notice. The SABC must, at the time of lodging such written response, provide proof to the satisfaction of the Authority that a copy of the response has been delivered by registered mail or facsimile to the relevant person(s) having made such written representation(s).
