THE INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA HEREBY ISSUES A NOTICE OF WITHDRAWAL REGARDING THE INVITATION TO APPLY FOR A RADIO FREQUENCY SPECTRUM LICENCE TO PROVIDE MOBILE BROADBAND WIRELESS ACCESS SERVICES FOR URBAN AND RURAL AREAS USING THE COMPLIMENTARY BANDS, 700 MHZ, 800 MHZ AND 2.6GHZ

The Independent Communications Authority of South Africa ("the Authority"), hereby issues a notice of withdrawal in respect of the following notices:

1. **General notice number 438 of 2016**, published in **Government Gazette Number 40145** regarding the "Invitation To Apply for a Radio Frequency Spectrum Licence to provide Mobile Broadband Wireless Access Services for Urban and Rural areas using the complimentary bands, 700 MHz", is hereby revoked.
